Introduction

From Helsinki to Crete and from Lisbon to Vilnius, specialised agencies have been established to provide services, information, know-how and advice to the European Union, its Member States and citizens.

The EU agencies are involved in many and varied activities: improving health, safety and the environment; safeguarding freedom, justice and security; supporting education, business and innovation; and developing transport and satellite infrastructure. Today the agencies play a key role in implementing EU policies and are making a valuable contribution to the EU 2020 strategic objectives.

With this exhibition, we aim to improve understanding of what our agencies do, why we exist, and how we impact on the lives of Europe's 500 million citizens.

As the European Parliament, Council and Commission work towards a common approach on agencies, we take stock of how far we have come and how we see the way ahead.

Thematic session 1

Transport and satellite infrastructure

Tuesday 1 February (9.30 – 14.00)

Overview

Europe's 500 million citizens need safe, effective transport systems, both for personal travel and for transporting the goods that we consume. The transport cluster focuses on how, together with the European Commission and Member States, the EU agencies help to 'keep Europe moving'. The cluster unites four agencies, three dedicated to transport by air, rail and sea — EASA, ERA and EMSA — plus GSA, the agency that manages the security and commercialisation aspects of the European satellite navigation programmes EGNOS and Galileo.

All agencies offer practical examples of how they help to keep Europe moving around the clock. Did you know that EASA managed the entire certification process of the Airbus A380 superjumbo? That via EMSA's SafeSeaNet system, the EU handled 1 500 million position messages from ships in European waters in 2010? That applications using the EGNOS system are so accurate that they can enable the control of racing cars to an accuracy of just a few centimetres? Or that ERA has set up a unified, interoperable system for registering trains, carriages and wagons?

Thematic session 3

Freedom, justice and security

Wednesday 2 February (9.00 – 14.00)

Overview

Working for a free, fair and safe Europe is the task of the EU agencies in this cluster. This they tackle from very different angles: from creating a common European security culture to promoting fundamental rights; from securing the information society to fighting cross-border crime and terrorism; from boosting police cooperation to combating gender inequality; and from informing drug policy to managing Europe's external borders.

The key concepts of freedom, security and justice frame the work of these agencies. These three concepts are inextricably linked and are based on some of the most cherished values and principles among Europeans today, such as democracy, equality, tolerance and the rule of law. People are only free if they are treated fairly and feel safe. Working towards this aim, the 10 agencies in this cluster cooperate in their daily work, as illustrated through examples during this exhibition.

Although the tasks of these agencies are diverse, each agency works to provide European added value by building on the best scientific and technical knowledge made available by Member States. The diversity of our tasks includes: evaluating the effectiveness of national and EU-level policies; providing advice and assessments; ensuring consistent implementation of legislation at Community level; and promoting the harmonisation of standards across Europe. Our opinions are based on networking national and EU scientific and technical expertise. By pooling expertise and information from across Europe, we are able to provide professionals, policymakers and EU citizens with transparent, impartial and objective advice.
