## concerning the adoption of a standard travel document for the removal/expulsion of third country foreign nationals

Draft Council Recommendation

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on European Union and in particular Article K.1 3(c) ;

Whereas combating unauthorised immigration residence and work by nationals of third countries on the territory of Member States is regarded as a matter of common interest ;

Noting that consultation and cooperation on the execution of expulsion measures is considered a priority action in the 1994 work programme ;

Acknowledging that a recent seminar on expulsion measures showed that the large majority of Member States experience difficulties in cases of third country nationals possessing no travel documents who are required to be expelled from their territory;

Desirous to improve the efficiency of executing expulsion measures ;

Hereby recommends that :

- with effect from 1st January 1995 the attached standard travel document valid for a single journey shall be used as appropriate by all Member States of the Union in the case of third country nationals being expelled from the territory of the Union
- the document shall be established in the language of the Member State executing the expulsion order
- the document, where appropriate, shall be translated into both French and English.
