

# Opening – two votes added on seeking ECJ opinion on EU-US data protection deal

**President Schulz announced that two motions for resolutions, seeking a European Court of Justice opinion on the compatibility with the Treaties of the EU-US deal on protecting personal data exchanged for law enforcement purposes, will be put to the vote on Thursday, immediately before the vote on the recommendation drafted by Jan Philipp Albrecht.**

The two motions for resolutions, tabled by the GUE/NGL and ALDE group respectively, under [Rule 108\(6\)](#), seek an opinion from the Court of Justice on the compatibility with the Treaties of the Agreement between the US and the EU on the protection of personal information relating to the prevention, investigation, detection, and prosecution of criminal offences.
