Refugee crisis: Commission reviews 2015 actions and sets 2016 priorities

Today, the College of Commissioners discussed the refugee crisis, looking at the measures taken in 2015 and the initiatives to be presented in spring 2016. Over the past year, an unprecedented rise in the number of people seeking international protection in Europe proved a major test for the Common European Asylum System and the Schengen area. The European Commission swiftly took measures to respond to the crisis, and continues to work with Member States and third country partners to manage the flow of people, protect Europe's borders, and address the root causes of these migratory pressures. First Vice-President Frans Timmermans said: "We can only get out of this crisis together. 2016 must see clear and tangible results in regaining control of irregular flows and of our borders, starting with the next weeks and months. We need to make sure hotspots are fully operational and that people who arrive are properly registered and fingerprinted, also tackling secondary movements. We must get the relocation scheme off the ground and return those who have no right to stay. We should also cooperate better with third countries to address root causes and stem the flow, as well as improve return and readmission. In 2016 we need to return to Schengen's normal functioning, and to do that we must ensure that Member States do not feel the need to introduce or prolong internal border controls. The Commission will do everything that is necessary for this to happen. In addition, we will come up with forward-looking thinking and bold steps to make sure our asylum system is future proof and to help manage migratory flows in a sustainable way." 2016 will be dedicated to delivering clear and tangible results and implementing the agreed measures, but also continuing to shape our future policies, including by adopting the Commission's announced proposals as soon as possible. The EU must step up its efforts in the fields of relocation, resettlement, hotspots, returns, and the establishment of a European Border and Coast Guard. In addition, the Commission will submit a proposal on the revision of the Dublin System by March, prepare a package of measures on legal migration and present a package on migrant smuggling by the end of 2016. To reduce the reliance on irregular routes, the Commission is also preparing a package of measures on legal migration. Finally, the Commission's recommendation for a voluntary humanitarian admission scheme with Turkey should be complemented with actions on the ground as well as a more structured framework for resettlement; and in regards to the external dimension of the crisis, partnerships and cooperation with key countries of origin, transit and destination will continue to be a focus. Commission provides additional support for fingerprinting of migrants in Greece

The European Commission has informed Greece of its decision to award €1.36 million in emergency funding for the acquisition of 90 fingerprinting devices. These devices will be used to ensure proper identification and registration of migrants at Greek border crossings. This emergency funding comes from the Internal Security Fund (ISF). The 90 fingerprinting devices and workstations will be connected to the central EURODAC system to ensure sharing of information, and will be installed at border crossing points throughout the country, including on the Eastern Aegean islands. This will help to ensure the full and effective operation of the hotspots established on the islands of Lesvos, Chios, Leros, Kos and Samos. This emergency assistance is part of the Commission's overall efforts to support concrete and effective actions in Member States facing high migratory pressure. For 2016, the Commission has foreseen emergency financial assistance, available to all Member States, of €55.9 million under the ISF programme and €133 million under the Asylum, Migration and Integration Fund (AMIF). This is in addition to the national AMIF and ISF programmes for all Member States. For Greece the national programme amounts to around €509 million for 2014-2020, of which €33 million has already been paid. The Commission's award decision will be followed by the signature of the grant agreement with the Greek authorities, which should take place in the following days. College of Commissioners discusses recent developments in Poland and the Rule of Law Framework

Today, the College of Commissioners held a first orientation debate on recent developments in Poland and the Rule of Law. The Rule of Law is one of the fundamental values upon which the European Union is founded. The Commission, beyond its task to ensure the respect of EU law, is also responsible, together with the European Parliament, the Member States and the Council, for guaranteeing the fundamental values of the Union. Recent events in Poland, in particular the political and legal dispute concerning the composition of the Constitutional Tribunal, have given rise to concerns regarding the respect of the rule of law. The Commission had therefore requested information on the situation concerning the Constitutional Tribunal and on the changes in the law on the Public Service Broadcasters. Following a presentation by First Vice-President Timmermans (responsible for the rule of law framework), Commissioner Oettinger (responsible for media policy) and Commissioner Jourova (responsible for justice), the College held a first debate on these developments in order to assess the situation in Poland under the Rule of Law Framework. Following today's orientation debate, the College mandated First Vice-President Timmermans to send a letter to the Polish government in order to start the structured dialogue under the Rule of Law Framework. Mergers: Commission opens in-depth investigation into acquisition of oilfield service provider Baker Hughes by Halliburton

The European Commission has opened an in-depth investigation to assess whether the proposed acquisition of oilfield service supplier Baker Hughes by rival Halliburton would impede effective competition in breach of the EU Merger Regulation. Commissioner Margrethe **Vestager**, in charge of competition policy, said: "*The Commission has to look closely at this proposed takeover to make sure that it would not reduce choice or push up prices for oil and gas exploration and production services in the EU. Efficient exploration and production of oil and gas resources within the EU form an important element of our Energy Union strategy in terms of ensuring security of supply.*" The takeover would bring together the world's second and third largest oilfield service suppliers, thus eliminating one of the three current main global competitors (i.e. Halliburton, Baker Hughes and market leader Schlumberger). The opening of an in-depth inquiry does not prejudge the final result of the investigation. The Commission now has 90 working days, until 26 May 2016, to take a final decision. Mergers: Commission clears acquisition of Nordex by Acciona

The European Commission has approved under the EU Merger Regulation the acquisition of Nordex SE of Germany by Acciona of Spain. Nordex is mainly engaged in the manufacture and marketing of wind turbines. Acciona is a diversified multinational conglomerate, with interests in areas such as infrastructure, construction and energy services. The Commission concluded that the proposed acquisition would raise no competition concerns, because the companies have a limited position on the market for the manufacturing of wind turbines and they will continue to face a significant number of large competitors. The Commission also assessed whether the transaction would allow the merged entity to engage in anticompetitive behaviour in related markets such as the market for the development of wind farms and the market for the generation and wholesale of electricity. However, the Commission concluded that given the companies' limited position on all markets concerned, competitors would continue to have sufficient alternative suppliers. The transaction was examined under the simplified merger review procedure. EUROSTAT: Industrial production down by 0.7% in euro area

In November 2015 compared with October 2015, seasonally adjusted industrial production fell by 0.7% in the euro area (EA19) and by 0.6% in the EU28, according to estimates from Eurostat, the statistical office of the European Union. In October 2015 industrial production rose by 0.8% and 0.6% respectively. In November 2015 compared with November 2014, industrial production increased by 1.1% in the euro area and by 1.4% in the EU28. A Eurostat press release can be found <u>here</u>.
