Subject: Operational Action Plans 2016 related to the EU's priorities for the fight  
against serious and organised crime between 2014 and 2017

---

### 1. Introduction

As foreseen by the mechanism of the EU policy cycle for organised and serious international crime<sup>1</sup>, the third Operational Action Plans (OAPs) for the new cycle 2014-2017 have been created.

They have to be produced on a yearly basis and contain actions in line with the Multi-Annual Strategic Plans<sup>2</sup> that have been set to achieve the new political priorities set by the Council in June 2013<sup>3</sup>.

The OAPs were prepared under the leadership of the Drivers through workshops held at Europol in October 2015. These drafts have subsequently been edited by the EMPACT Support Unit at Europol in order to ensure the highest possible level of standardisation between them and submitted to the National EMPACT Coordinators during their meeting on 24-25 November 2015. They were subsequently discussed in the COSI SG meeting on 10 December 2015. The EMPACT Support Unit has also prepared a table in the annex which outlines operational actions (OA) of the OAPs which might have potential overlaps with other OA in other OAPs.

In addition, the General Secretariat of the Council has prepared an overview in ADD 1 (EU RESTRICTED) and in ADD 2 (EU RESTRICTED) (for Illegal Immigration), which highlights some elements, mainly operational ones, of the different OAPs 2016.

In accordance with action 36 of the EU policy cycle<sup>4</sup>, COSI validated the OAPs on 16 December 2015.

## 2. Contents

The OAPs were developed according to a template set out in 9940/13. They comprise the related priority, its potential overlap with other priorities, the management and support, the methodology, and finally a table with the detailed operational actions planned for 2016.
