Report from the Danish delegation.

To the Police Co-operation Working Party.

Concerning the result of new questionnaire inquiries relating to assistance to Eastern European Countries.

By note of 18 July 1994, transmitted on 19 July 1994 via the TREVI Secure Fax Network by TREVI report no. 11/329/94 and on 26 July 1994 by the Council Secretariat in doc. 8733/94 ENFOPOL 91, the Danish delegation circulated a new questionnaire concerning police co-operation with the countries of Eastern Europe.

The new questionnaire is a follow-up of a previous questionnaire review, on which the Danish delegation submitted its report by doc 5130/94 ENFOPOL 28.

The new questionnaire, circulated by the above-mentioned note of 18 July 1994, was drawn up by the Danish delegation following consultations with the German, Irish, and Netherlands delegations.

In consideration of the feasibility of reporting to the meeting of the Police Co-operation Working Party scheduled for September 1994, 15 August 1994 was fixed as the time-limit for receipt of replies to the new questionnaire.

As of 1 September 1994 the Danish delegation had received replies from the following delegations:
Italy, United Kingdom, France, Greece, Portugal, Luxembourg, Germany, Ireland, Finland, and Norway as well as from the Commission.

In their format, the replies received do not lend themselves to immediate comparison, and therefore, the Danish delegation has chosen to attach the replies as annexes to this report. This must also be viewed in the light of the fact that not all delegations have replied to the questionnaire in due time.

SERVICES OF EASTERN EUROPEAN COUNTRIES

In connection with message 224/B3/459/2105/R, dated 22/4/94, we are forwarding the following additional information. In the framework of initiatives envisaged by Act 212, dated 26/2/92, the following supplies have also been carried out, in favour of Albania:

- contract number 25240, dated 16/3/93, IBM SEMEA - 2,349,060,000 Lit. plus VAT: intelligence telematic network among Countries involved in the fight against drug trafficking;
- contract number 25238, dated 16/3/93, OLIVETTI - 4,725,812,125 Lit. plus VAT: establishment of a computerized system for Albania;
- contract number 25239, dated 16/3/93, MARCONI - 4,237,000,000 Lit. plus VAT: telecommunication network for Albanian Police Forces.

Furthermore the establishment of a Data Transmission connection between Rome and Ankara is envisaged, whose cost is still to be determined (the Italian Ministry of the Interior and the Turkish Ministry of Post are discussing the terms of the commercial agreement).

QUESTIONNAIRE CONCERNING POLICE CO-OPERATION WITH THE COUNTRIES OF EASTERN EUROPE

- A The assistance provided to police forces in central and eastern Europe is financed by the British Government's Know How Fund, Britain's programme of bilateral technical assistance to the region. The individual programmes are administered on behalf of the Foreign and Commonwealth Office (FCO) by specific UK police forces. The programmes' details are agreed annually following discussions between the relevant countries' police officers and Government officials, the FCO and the appropriate UK police advisers. Requests are amended as necessary according to the circumstances.

Assistance in all countries takes the form of training visits by UK police officers and experts from related fields to the region and/or training in the UK for central and eastern European police officers. It involves the transfer of knowledge rather than equipment. There has not been any cooperation with other EU Member States although our police advisers are often aware of other states' programmes.

Central Europe

Poland (1990 - ongoing)

Assistance requested by the Polish Police and administered by a retired UK police officer.

Programme includes assistance in the following areas: personnel training at all levels in organisational and management systems; policing methods; economic/organised crime; crime surveillance and prevention; forensic science; serious crime; emergency planning; police dogs and mounted horses; criminal justice.

Current annual cost: £150,000.

Hungary (1990 - ongoing)

Assistance requested by the Hungarian National Police and administered by the Merseyside Police.

Programme includes assistance in the following areas: personnel training at all levels; policing methods; crime prevention; fraud-related crime; serious crime; computer skills; public safety and public order; domestic violence; English language training.

Current annual cost: £60,000.

Bulgaria (1991 - ongoing)

Assistance requested by the Bulgarian Police and administered by the Metropolitan and Gwent Police.

Programme includes assistance in the following areas: personnel training and career development; organised crime and money laundering; drugs-related crime; forensic science; operations/crime; criminal justice; public order and traffic management; public/press relations; criminal justice; community and race relations.

Current annual cost: £110,000.

Romania (1992 - ongoing)

Assistance requested by the Romanian Police and administered by the Devon and Cornwall Police.

Programme includes assistance in the following areas: personnel training; organised crime and money laundering; forensic science; accident prevention and traffic management; youth justice, sexual offences and child abuse.

Current annual cost: £35,000

Czech Republic (1991 - ongoing)

Assistance requested by the Czech National Police and administered by the Humberside Police.

Programme includes assistance in the following areas: personnel training; career development and financial management; crime prevention; drugs-related issues; organised crime; policing methods; mounted police; white collar crime.

Current annual cost: £80,000

Slovak Republic (1991 - ongoing)

Assistance requested by the Slovak Police and administered by the Humberside Police.

Programme includes assistance in the following areas: personnel recruitment, training and career development; organised crime and money laundering; policing methods; crime prevention; community policing.

Current annual cost: £80,000

Albania (1992 - ongoing)

Assistance requested by the Albanian Police and administered by the Essex Police.

Programme includes assistance in the following areas: criminal justice; policing methods; crime investigation; economic crime.

No programme planned for 1994/95.

Baltic States

Estonia (1992 - ongoing)

Assistance requested from the Estonian Government and administered by Strathclyde Police.

Programme includes assistance in the following areas: upgrading of instructional skills in leadership training; relations with the media; study of criminal investigation techniques; attachment to Scottish Police College for teaching techniques.

Current annual cost: £38,600.

Latvia (1992 - ongoing)

Assistance requested from the Latvian Government and administered by Strathclyde Police.

Programme includes assistance in the following areas: criminal intelligence; forensic study; explosives training; traffic law enforcement; attachment to Scottish Police College for teaching techniques.

Current annual cost: £43,200.

Lithuania (1992 - ongoing)

Assistance requested for the Lithuanian Government and administered by Strathclyde Police.

Programme includes assistance in the following areas: traffic law enforcement; police driver training; forensic science techniques; criminal investigation techniques; attachment to Scottish Police College for teaching techniques; management training for senior police officers.

 - a) On 21/6/94 the Ministry of Public Order of our country received a request from the corresponding Ministry of Albania for technical equipment needed by the Albanian Police. Most of the requested items (telecommunication material, two Police buses, radio and photographic material as well as clothing and footwear) were delivered to the Albanian Police on 22/12/92 .
 - b) In the framework of the programme PHARE, the competent service of the General Directorate of Customs, coming under the Ministry of Finance, was assigned to carry out a training course in Bulgaria including seminars and setting up of legislation, regarding the precursor substances for making narcotics. The programme regarding the setting up of legislation has already finished, while the programme of organizing seminars is due to be complete in the next months.





Denmark has received requests of extremely different sorts. It should be underscored, however, that Denmark has not received requests for financial support only.

Denmark is of the opinion that assistance should focus primarily on training and attitudinal aspects. These views will be communicated to recipient States already during preliminary discussions. As a matter of course, this will have affected the nature of requests made by such States.

5. The extent to which the request has been met.

Not all request have been met. No request, however, has been totally rejected.

6. An estimate of the cost.

It is not possible to provide an estimate of the costs, which have been relatively modest, however.

7. Co-operation with other EU Member States.

Discussions are still ongoing with the Netherlands on joint organisation of a seminar for the police in Lithuania.

Further, it must be mentioned that close co-operation is taking place among the Nordic countries. Co-operation is particularly close in relation to the Baltic States (Estonia, Latvia, and Lithuania). The Nordic National Commissioners have agreed that in principle each of the Nordic countries will concentrate its assistance on one of the Baltic States. For Denmark, this applies to Lithuania.



Subject : New questionnaire concerning police co-operation with the countries of Eastern Europe

We offer the following replies to the questionnaire :

A.

The Ministry of Justice and the Norwegian police authorities have until now received no formal requests for assistance from Central or Eastern European countries. Nor has Norway on its own initiative offered such assistance to the governments concerned. A few requests for information on legislation etc. have been met.

No equipment or other material has been provided, except in a single case (Interpol Riga). In this connection, officers from Interpol Riga were also invited to Oslo on a study tour in the fall of 1993. This assistance project took the form of Interpol Oslo to Interpol Riga directly.

The matter was discussed at the last meeting of the Nordic national police commissioners in June 1994 - a meeting which was also attended by the Baltic national police commissioners. It became apparent that these countries want assistance from the Nordic countries to structure, equip and train their police forces. A Nordic working group has since been set up to plan and coordinate Nordic assistance to the Baltic states in the field of police training

and competence building measures. (This is well known to the Danish delegation of course.)

The Ministry of Justice intends to contribute to whatever projects and plans that may emerge from this joint Nordic effort.

Subject: Police cooperation with the countries of Central and Eastern Europe

In accordance with the proposal made by the Danish delegation in the note (ENFOPOL 73) of 27 May 1994 to update the report on assistance provided by Member States to police in the countries of Eastern Europe (ENFOPOL 28), and with the revised questionnaire of 26 July (ENFOPOL 91), the Secretariat General of the Commission submits the attached note for information.

The paper is a revised version of the report given to Denmark in August 1993, and describes Commission activity, which is largely concentrated on the fight against drugs. There have been a number of significant developments in the last year, such as entry into force of the Association Agreements with Hungary and Poland, and extension of the PHARE programme, both geographically and financially.

Commission activity in this field is of a somewhat different nature to that of the Member States, so the report does not conform with the format of the Member States' responses. Denmark might therefore consider whether circulation to the Member States would be useful.

Community Assistance programmes to Eastern European Countries in the field of the Fight against Drugs

With the sharp increase in drug trafficking and drug related crime through the countries of Central and Eastern Europe, the European Community, and now the European Union, attached great importance to assisting these countries in establishing effective measures to combat illicit trafficking and to cope with their growing problems of drug abuse. Illicit trafficking of South-west Asian heroin along the Balkan Route, with Turkey as a gateway for Europe, continues to be the major drug control problem. The war in former Yugoslavia has resulted in the alteration of the "traditional" Balkan Route. The supply and traffic chain now extend to Central Europe. The increasing transit of narcotics through countries in the region, connected with the growing involvement of East European nationals, is leading to the establishment and expansion of new local consumer markets. Furthermore, trafficking routes are changing and the disintegration of the former USSR has revealed the existence of new production areas, as well as trafficking networks, particularly of south-west Asian heroin smuggled through the CIS. The illegal cultivation of cannabis and opium poppy is reportedly widespread, especially in the Central Asian CIS countries. In addition, the CIS and the Baltic States are being used as "transit points" for illicit narcotics en route to final consumer destinations in the EU and other Nordic countries. According to the 1993 Report of the International Narcotics Control Board (INCB), trafficking in the region continues to grow with rising criminality and with virtually no control mechanisms in place.

On the basis of the European Plan to Combat Drugs (December 1990, revised and updated in December 1992), the European Union started systematically integrating a drugs priority within the new bilateral agreements with Central and Eastern European countries. The updated European Action Plan, proposed by the Commission on 8 June 1994, proposed the continuation and development of this policy. Within this context, articles on co-operation in the field of drugs as well as on money laundering have been introduced into the Association Agreements with Poland, Hungary, Romania, Bulgaria, the Slovak Republic and the Czech Republic (the "Europe Agreements"). The Association Agreements with Hungary and Poland have entered into force on 1 February 1994. The ratification procedures of the other Association Agreements have been started. This cooperation aims at increasing the effectiveness and efficiency of policies and measures to counter the supply and illicit traffic of narcotics drugs and psychotropic substances, and to promote drug demand reduction.

A similar approach has been followed in the negotiation of the Partnership and Cooperation Agreements with a number of Republics of the Newly Independent States (NIS) of the Former Soviet Union, such as Russia, Ukraine (the Agreements are signed but have not yet entered into force), Belarus, Kazakhstan, Kyrgyzstan and Moldova (currently under negotiation).

In that context, the Commission approved in November 1992 the financing of a 2 MECU Regional PHARE pilot Programme for the fight against drugs in Poland, Hungary, the Czech Republic, Slovakia, Romania and Bulgaria. This PHARE Programme is being strengthened and geographically extended to cover the abovementioned countries as well as the three Baltic States, Slovenia and Albania, under a 10 MECU Regional PHARE Programme on Drugs for the period 1994-1996 which was agreed upon in December 1993. Implementation of these PHARE Programmes are being done in consultation with the Pompidou Group of the Council

On the basis of the conclusions of the Copenhagen European Council (June 1993), the Commission is seeking from the Council the mandate to open negotiations with Bulgaria, the Czech Republic, Hungary, Poland and the Slovak Republic for the conclusions of Additional Protocols to the Europe Agreements. These Additional Protocols will specify, in particular, the fields where these countries will be able to participate in Community framework programmes, specific programmes, projects or other actions, the fight against drugs and drug addiction being one of these. The Association Council established by the Europe Agreements will decide the terms and conditions for participation in these activities. The participation of the Central and Eastern European countries in the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA) could be, when appropriate, an example in the drugs field.
