Subject: Scientific and technical research

- Research projects on criminology and criminal matters

I. Preliminary remark

For the first time it is possible to present an EU-wide analysis of transnational research projects on criminology and criminal matters carried out or initiated by institutions connected with the police or judiciary. There are fifty such projects in all, including

- 27 projects from Germany
- 4 projects from Denmark
- 5 projects from France
- 6 projects from United Kingdom
- 8 projects from Italy
- Luxembourg reported that it had no such projects

The precise designation of the projects, together with the type of project and the progress of research, will be found in the Annex.

The following points were noted during analysis of the questionnaires received:

- some of the questionnaires were not fully completed; i.e. not all questions were answered or the descriptions supplied were of projects unconnected with the questionnaire.
- Although only transnational research projects in the field of criminology and criminal matters were supposed to be mentioned there were references to
 - -- projects devoid of any transnational character
 - -- and projects concerned with purely technical aspects of detection work

- Projects concerned with purely technical aspects of detection work are not dealt with here.

II. Individual analysis

1. Main fields of research covered by the projects

It is possible to identify 6 focal points among the fields of research concerned with criminology and criminal matters. There are also national focal points as the following summary shows.

2. Duplicate or parallel research

Crucial to the analysis of the 50 research projects was the question whether there was any sign of duplicate research. As some questionnaires were incomplete or unspecific this initial analysis can do no more than indicate <u>possible</u> duplicate research. It was nonetheless possible to identify 5 areas of research in which duplication may be occurring.

- (a) France's planned projects on
 - Analysis of interaction between the European police cooperation area and that of national security
 - Transfrontier cooperation in connection with the Channel Tunnel and the Franco-German border

and the United Kingdom's already completed research project on

- A system of European police cooperation after 1992
- (b) The United Kingdom's planned research project
 - EURO-NARC (A study of trends in European drug enforcement)
 and Germany's already completed project on
 - Preventive models in the field of drug-related crime
 and the ongoing German project on the
 - Duration and development of addiction in drug-dependent subjects
- (c) The completed Danish project
 - Crime forecasts for the year 2000

and the ongoing French project

- Fraud involving Community subsidies

and the ongoing German project

- EC Internal Market project
- (d) The United Kingdom's planned research project on
 - Transnational Crime issues of management and strategy for the police

and Germany's completed project on

- Effectiveness and efficiency of special forms of organizations set up on a temporary basis
- (e) Denmark's ongoing project on
 - Profile of rape cases

and Germany's completed project on

- Violence against women in marriage and common-law marriage.

3. Research methods used

Given that some questionnaires were not properly completed the results of the analysis of the research methods used need to be treated with due caution.

Here too there appear to be national points of emphasis. The German projects, for example, were predominantly based on oral questioning of individuals, consultation of experts and written questionnaires.

The most commonly used methods were oral questions such as individual interviews or discussions with experts.

The second most frequently mentioned method was the analysis of files and documents, followed by written enquiries.

Finally, there was the analysis of existing information (e.g. in computer systems).

All things considered, it is possible to say that for all its teething troubles this first EU-wide analysis of transnational research projects concerned with criminology and criminal matters initiated or carried out by research institutions connected with the police or judiciary

can certainly be regarded as a valuable means of exchanging specific information, of drawing attention to possible duplication of research and of encouraging cooperation in the field of research into criminology and criminal matters.

We therefore urge that the project be continued, updated at six-monthly intervals and the results made available to the Member States of the European Union.

It would make sense for this task to be assumed by a single Member State, to be determined.
