Subject: Draft note to COREPER/Council for information on the texts adopted in the migration and asylum areas transmitted or to be transmitted to the CEECs

Delegations will find hereafter the above-mentioned draft note, including a list of texts adopted by the Ministers (before the entry into force of the Maastricht Treaty) and by the Council, as it resulted from the Asylum Working Party with experts in migration matters on 17 April 1997. ## "I/A" NOTE

Subject: Texts adopted in the migration and asylum areas transmitted or to be transmitted to the CEECs
