Subject : Compilation of information on readmission agreements concluded by Member States (see Telex No. 1066 dated 9 March 1998 and paragraph 9 of document 6297/98 ASIM 52 CIREFI 11)

Delegations will find herewith a compilation of information received from Denmark, Greece, Spain, the Netherlands, Portugal, Finland, Sweden and the United Kingdom, on bilateral readmission agreements concluded by them.

The information from Germany and Austria is in the process of being translated.

Belgium, France, Ireland, Italy and Luxembourg have not as yet submitted any information.

It is recalled that a survey of the readmission agreements concluded with the CEECs is contained in document 12423/7/95 CIREFI 56 REV 7 (update of April 1997) and a survey of the readmission agreements concluded by Schengen States is contained in document 7424/98 ASIM 91 (update of November 1997).

Greece has concluded readmission agreements with CROATIA, SLOVENIA, ROMANIA, POLAND and BULGARIA, and that negotiations are under way for the conclusion of similar agreements with HUNGARY, INDIA and PAKISTAN.

Information on readmission agreements is as follows:

- Agreement between the Government of the Kingdom of Spain and the Government of the French Republic on the admission at frontier posts of persons illegally resident, signed in Madrid on 8 January 1988
- Agreement between the Kingdom of Spain and the Kingdom of Morocco on the movement of persons in transit and the readmission of illegal aliens, signed in Madrid on 13 February 1992
- Agreement on the readmission of persons in an irregular situation, done at Brussels on 29
 March 1991 by the Contracting Parties to the Schengen Agreement and the Republic of Poland. Spain acceded to this Agreement on 27 October 1992
- Agreement between the Kingdom of Spain and the Portuguese Republic on the readmission of persons in an irregular situation, signed in Granada on 15 February 1993; in force since 2 April 1995
 - Agreement between Spain and Romania on the readmission of persons in an irregular situation, signed in Bucharest on 29 April 1996. Has been provisionally applied since 24 May 1996 pending completion of parliamentary proceedings
 - Agreement between the Kingdom of Spain and the Republic of Bulgaria on the readmission of persons in an irregular situation, signed in Sofia on 16 December 1996. Has been provisionally applied since 15 January 1997.

There are likely to be certain countries, such as Somalia and Ethiopia that cause problems to all parties.

Delegations will find herewith the information received from Germany and Austria on bilateral readmission agreements concluded by them.

Belgium, France, Ireland, Italy and Luxembourg have not as yet submitted any information.

- Readmission Agreement with the Government of the Republic of Hungary

The Agreement between the Government of the Federal Republic of Germany and the Government of the Republic of Hungary dates from 1 December 1997. It has not yet entered into force, as notification procedures are not complete.

The readmission agreement provides mutual confirmation that each of the Contracting Parties is under a duty to take back its own nationals; in addition, it allows third-country nationals to be taken through the territory of the other Party in transit, and lays down an obligation for each Party to take back third-country nationals with residence permits for its territory who have entered the other Contracting State illegally or whose residence there has become illegal following initial (legal) entry.

One of the main aims of the agreement is to place an effective and swift curb on illegal immigration within Europe. It is also intended as a useful tool in combatting cross-border organized crime - particularly immigrant smuggling rings.

Agreement with the Federal Government of the Republic of Austria

The Agreement between the Government of the Federal Republic of Germany and the Federal Government of the Republic of Austria on the readmission of persons at the border was signed on 16 December 1997. It entered into force on 15 January 1998.

In addition to mutual confirmation of the duty on the Contracting Parties to readmit their own nationals, the agreement allows third-country nationals to be taken through the territories of the respective Contracting States in transit and also establishes a duty to take back third-country nationals who have entered the requesting State illegally from the territory of the requested State, i.e. who did not fulfil the requisite entry conditions (passport, visa) when they crossed the border.

The aim is to step up direct cooperation between the police and customs authorities of the Contracting States in the border area in order to stem the flow of illegal immigration and help to combat cross-border organized crime effectively - especially given the growing menace of immigrant smuggling rings.
