The European Commission adopted the New Pact on Migration and Asylum on 23 September 2020, which contains a strong component on partnerships with third countries.

This document provides an updated overview of the main external migration dialogues and processes since 2019. The document is compiled for the information of the Working Party on the External Aspects of Asylum and Migration by the responsible European Commission and EEAS services.

This document also serves as a tool to follow-up the implementation of the European Council Conclusions (on external aspects of migration) as well as the outcomes of meetings of the Home Affairs and the Foreign Affairs Ministers.

This document was formally known as the Global Approach to Migration Management (GAMM) update covering dialogues and processes since 2005.

Part 1- Bilateral dialogues

A. AFRICAN COUNTRIES

CABO VERDE

In 2007, the EU and Cabo Verde agreed on a Special Partnership Agreement and a Joint Declaration on a Mobility Partnership with Cabo Verde was signed in 2008. In December 2014, a visa facilitation and a readmission agreement, entered into force. The visa facilitation agreement was jointly evaluated in 2017 and the text has been subsequently amended to include further mobility facilitation. The negotiations started in October 2019 and were concluded on 24 July 2020. On 18 March 2021, the amendment of the EU-Cabo Verde Visa Facilitation Agreement was signed in Brussels. The European Parliament voted on the amended agreement on 15 September 2021 and it was adopted by the Council on 7 October 2021. On 3 May 2022, Cabo Verdean authorities informed the Council that the ratification process had been completed and the amended agreement entered into force on 1 July 2022.

CAMEROON

Cameroon is a country of origin with an increasing migration rate to the EU. It has bilateral readmission agreements with ES, FR, BE. The number of voluntary returns managed by IOM for Cameroonian nationals has been increasing. Despite ongoing discussions on the topic, Cameroon does not yet have a national migration policy. There is no governmental body responsible for the design, coordination and implementation of a migration policy or a national strategic plan on migration. The latest EU-Cameroon structured political dialogue (June 2023) focused i.a. on regular and irregular migration and adopted on the political level the recommendations of a migration" technical sub-committee, whose first meeting took place in early November 2022, marking the commitment of both sides to make concrete progress in this field.

ETHIOPIA

The Common Agenda on Migration and Mobility (CAMM) was signed by the EU and Ethiopia in November 2015. A Joint Declaration "Towards an EU-Ethiopia Strategic Engagement", including a sectoral dialogue on migration, was signed on 14 June 2016. Procedures for the identification and return of Ethiopian irregular migrants from Europe were approved by the Council on 29 January 2018. The Joint Working Group under the Procedures is planned for February 2024

MAURITANIA

With the resumption of the irregular flows on the Atlantic route in 2019, followed by a sharp increase in 2020, the EU stepped up its engagement with Mauritania, particularly in relation to border management. Mauritania has been identified as a priority country for a closer cooperation with Frontex, in the form of a working arrangement and/or a status agreement, depending on Mauritania's needs and interests. The country previously showed some interest in both the status agreement and the working arrangement, but negotiations on the status agreement stalled after a few rounds in late 2022-early 2023. Negotiations are ongoing with Frontex on the working arrangement. A comprehensive approach addressing irregular migration through a multi-dimensional response, including enhanced support to the creation of job and training opportunities is pursued through the Joint Declaration that was signed on March 7th 2024.

Under this new high level migration partnership, we aim to:

- Strengthen our collaboration to prevent and reduce irregular migration flows to the EU. With this in mind, you need to ensure that Mauritania delivers on its commitment to reduce flows (and return to the situation before December 2023).*
- Tackling the problems of forced displacement from Mali to Mauritania and reassuring them of our support to ease the pressure on the Hodh El Chargui region, which hosts the bulk of asylum seekers and refugees, and to foster social cohesion and inclusion, in line with the commitments made by the Mauritanian government at the Global Refugee Forum.*
- Improve governance and support democracy and stability in a fragile region where democratic backsliding is the dominant trend and a presidential election is scheduled to take place in Mauritania on 22 June 2024.*
- Strengthen maritime and land border management, including search and rescue, to control and reduce irregular flows to the EU and better protect migrants and persons in need of international protection.*
- Strengthen cooperation with EU agencies within the overall migration management framework, in particular with Frontex. In this spirit, encourage Mauritania to continue negotiations on the working arrangement, which is part of the package.*
- Call on Mauritania to keep cooperation on migration management high on the African Union's agenda as Chair of the continental body for 2024-2025.*

NIGER

High-Level Dialogue on migration launched on 18 September 2015. The EUCAP Sahel Niger mission was enlarged in July 2015 including a new objective on migration. The EUCAP field office in Agadez opened April 2016. Since November 2017, refugees have been evacuated in a humanitarian evacuation scheme from Libya to Niger via the Emergency Transit Mechanism in Niger. An Action Plan on Niger has been elaborated in EMWP, in December 2021. An action file on Niger was discussed in MOCADÉM in February 2022. On 15 July 2022, an Anti-Smuggling Operational Partnership was launched. Following the coup on 26 July 2023, the cooperation with Niger authorities was put on hold. The projects implemented by international organisations in the benefit of the migrants, asylum seekers and refugees continue.

NIGERIA

Under the umbrella of the EU-Nigeria Ministerial meetings, several political dialogues on migration have taken place in the last few years. A Common Agenda on Migration and Mobility (CAMM) was signed on 12 March 2015. After 13 rounds of negotiations of the EU Readmission Agreement negotiations, the Nigerian Ministry of Justice informed the EU Delegation of its green light on the document in a May 2024 meeting, while Nigeria would still like to clarify for itself the relationship of the EU RA with the bilateral Nigeria-MSs RAs. In a May 2024 IMEX meeting, several MSs already signalled not agreeing to some of the EU RA provisions as negotiated.. On 19 October 2023 a Strategic dialogue took place between the EU (Commissioner Urpilainen in the lead, associating Commissioner Simson) and Nigeria (Minister for Budget and Economic Planning + 5 Ministers) that also addressed migration management. Nigeria signed the EU-OACPS Partnership Agreement (Samoa Agreement) on 28 June 2024.

These negotiations are embedded in wider EU-Nigeria relations on migration and mobility.

Nigeria features on the list of priority partners to conclude Working Arrangements, although at the moment the Agency is not entering into any new negotiations, due to the ongoing revision of its external strategy.

An Action Plan on Nigeria has been elaborated in EMWP, in December 2021. An action file on Nigeria was discussed in MOCADDEM in March 2022.

As outlined in the Communication on Attracting Skills and Talent to the EU published on 27 April 2022, the Commission has started assessing the feasibility of launching a Talent Partnership with Nigeria as one of the key components of a reinforced migration management cooperation with this country. Nigeria's agreement to the readmission agreement is the first step towards a comprehensive partnership, of which the Talent Partnership would be a component.

REPUBLIC OF CONGO

There is no structured dialogue on migration between the EU and the Republic of Congo (RoC). Due to the low numbers of immigrants from RoC into the EU, migration is not included among the issues raised in bilateral meetings or political dialogues. On readmission, apart from the ACP- EU Cotonou Agreement, to which the RoC is party (replaced by the Samoa Agreement, signed on 15 November 2023 and that is now provisionally applicable), there is no other cooperation instrument or process in place at the EU level. Among MS, only France has a relevant bilateral agreement in place. In the context of article 25a of the Visa Code, the EU has reached out to RoC's authorities in order to explore ways to improve cooperation.

DEMOCRATIC REPUBLIC OF THE CONGO (DRC)

There is no structured dialogue on migration between the EU and the Democratic Republic of the Congo (DRC). Due to the low numbers of immigrants from DRC into the EU, migration is not included among the issues raised in bilateral meetings or political dialogues. On readmission, apart from the ACP- EU Cotonou Agreement, to which the DRC is party (replaced by the Samoa Agreement, signed on 15 November 2023 and that is now provisionally applicable), there is no other cooperation instrument or process in place at EU level. Among MS, Belgium and France have signed a bilateral agreement with DRC on migration matters, which includes for example forced return and the possibility to organize Joint Return Operations (JRO). A Eurlo is deployed in Kinshasa. There is a project on signing "Best practices" with Frontex, which will allow also to make returns to DRC more smoothly. The EU will continue to reach out to DRC's authorities in order to explore ways to improve cooperation.

SENEGAL

Partnership compact launched by visit of Commissioner Avramopoulos in Dakar on 26 July 2016.

Political dialogue with the EU on migration started in 2016, but political commitments have not been fully turned into action so far; progress on returns and readmissions from Europe remains limited. Due to insufficient cooperation on readmission, Senegal was proposed for Visa Restrictive measures under article 25a of the Visa Code in November 2022. In September 2022, Senegalese authorities accepted the principle of a regular dialogue on migration, (one or two times a year), and agreed to a readmission related indicator in the budget support for 2023, which however was not fulfilled – the reference period has been extended for another year.

In 2020, Senegal has pleaded for more legal pathways towards the EU. Following the significant increase of irregular flows towards the Canary Islands, as well as several shipwrecks and incidents which affected Senegalese nationals, Senegal has asked the EU and relevant EUMS to enhance joint efforts in reducing irregular flows, fighting migrant smugglers and saving lives at sea.

Following the Joint High-level visit of the President of the Commission and several Commissioners, in February 2022, technical discussions are ongoing on ways to strengthen cooperation with Frontex on border management .

On 9 November 2022, Commission tabled a proposal on visa restrictive measures for discussion at the Council. This proposal triggered an enhanced cooperation from Senegalese side with commitments to improve cooperation on return and readmission at the occasion of DG HOME mission to Dakar in December 2022. Leaving time to Senegal to deliver on its commitment, the COM proposal is put on hold at Council level and discussions continued in 2023 with some progress and also room for more substantial efforts. The discussion have continued under SE, ES and now BE presidencies.

Following VP Schinas visit in October 2023, Senegalese authorities organized an internal coordination meeting to reply to FRONTEX proposal on the working arrangements, no response has yet reached the Commission.

As outlined in the Communication on Attracting Skills and Talent to the EU published on 27 April 2022, Senegal is indicated as one of partner the countries for which a Talent Partnership could be considered, as one of the key components of a reinforced migration management cooperation with this country and part of a comprehensive approach, pursuing on all relevant migration areas. . It is considered that the timing to launch a talent partnership is not ripe, considering the overall level of cooperation, including on readmission.

The political developments of the first week of February 2024 with the announced postponement of the presidential elections are to be monitored as this could have an impact on the different strands of migration with Senegal including delivering on budget support indicators, cooperation on returns, collaboration with FRONTEX, root causes of migration and protection.

CHAD

There is no structured dialogue on migration between the EU and Chad. Due to the low numbers of immigrants from Chad into the EU, migration is not included among the issues raised in bilateral meetings or political dialogues. On readmission, apart from the ACP- EU Cotonou Agreement, to which Chad is party (replaced by the Samoa Agreement, signed on 15 November 2023 and that is now provisionally applicable), there is no other cooperation instrument or process in place at EU level.

Key past and upcoming events

GUINEA

Guinea is a country of departure and transit for migration. Guinea moved from 11th place in 2019 to 1st place in 2023 among African countries of origin of irregular migration in Europe.

Irregular migration is facilitated by weak border management by national authorities (weak controls, corruption, lack of resources, etc.), which fosters the rise of organised crime, including trafficking in human beings and smuggling of migrants. In addition, the country has to deal with a high number of returning migrants, both voluntary and not from Europe or African countries along the Atlantic/Western Mediterranean route/and the Central Mediterranean route without having the capacity to do so.

Until December 2023, the authorities' capacity to respond to the reintegration needs of migrants was satisfactory. To date, difficulties have also emerged regarding the procedures of returns, notably with the delivery of travelling documents, which remains very limited. EU support to the Ministry of Youth allowed to put in place action protocols for returnees. However, improvements are necessary regarding the flow of information between the relevant structures, and in the implementation of integration and job creation policies. No formal political dialogue between the EU and the Republic of Guinea took place after the 2021 coup until autumn 2023. Commission Vice-President, Mr. Schinas, met Guinean authorities on September 26 during a visit to Conakry, relaunching the formal dialogue between the two parties, especially on migration-related issues.

A follow-up visit by the Guinean Minister of Foreign Affairs, Mr. Morissada Koyate, took place in Brussels on October 23, 2023, during which the Minister met with Vice President Schinas, the EEAS Director General for Africa and the Director of INTPA for Africa. In November 2023, the EU and Guinea launched a joint project to support integration and decent employment through vocational training, for an amount of 26.5 million euros. The EEAS Director General for Africa visited Conakry in April 2024 where the Prime Minister confirmed the commitment of Guinea to improve their cooperation in terms of returns. In June 2024, EEAS Director General for Africa, together with the DDG Luchner met with the Minister of Foreign Affairs in Brussels to reaffirm the engagement of the Prime Minister to improve their returns policy. The 6th EU-Guinea Joint Working Group took place in Brussels in July 2024.

With the resumption of high-level political dialogue on the migration issue, progress in terms of returns/readmissions is expected. The implementation of Guinean migration policy is among Guinea's political priorities.

There is no structured dialogue on migration with Guinea; discussions are focused mainly on returns via the EU Guinea Joint Working Groups whereby DG INTPA/EUDEL provide an update on programming/ongoing projects if required. Support to the national authorities on reintegration and fighting irregular migration, including smuggling of migrants and trafficking in human beings is being envisaged.

COTE D'IVOIRE

In 2023, Côte d'Ivoire ranked as one of the main countries of origin of irregular migrants from Sub Saharan Africa (17 905 Ivorian nationals in 2023, 96 in Jan 2024). Migration is a sensitive issue, Ivoirian identity issues and land conflicts involving migrants' access to land are one of the root causes of conflicts. For this reason, Côte d'Ivoire is included in the Team Europe Initiatives on the Atlantic/Western Mediterranean Route, and on the Central Mediterranean route.

Côte d'Ivoire has expressed on several occasions its dissatisfaction with the communication in the public sphere the figures of irregular arrivals of Ivorian nationals to the EU (in particular to Italy), stressing that they are to be considered "presumed" Ivorian nationals

Côte d'Ivoire has raised the point that 26% of the total population in Ivory Coast is not Ivorian (mainly from Burkina Faso, Mali, Guinea, Benin) and underscored the importance of tackling irregular migration and the fight against migrant smuggling, as well as trafficking in human beings.

Joint document of the Government of the Ivory Coast and the European Union on the procedures for identification and readmission of migrants presumed to be Ivorian nationals staying irregularly in the European Union (2018), as well as the holding of regular follow-up meetings. Regular dialogues since 2019.

5th meeting of the EU-Côte d'Ivoire Joint Working Group on the implementation of the readmission arrangement (Joint document) Abidjan, Côte d'Ivoire 28 September 2023. Cooperation on migration is positive and additional funding through the Flexible Mechanism has been validated, in the area of Civil registry – Document Fraud and Reintegration.

GAMBIA

With a population of 2.3 million, The Gambia is one of Africa's smallest countries. Migration plays a significant role in Gambian society. The Gambia is a country of origin in terms of irregular arrivals to the EU (9247 persons in 2023, compared to 1326 in 2022), and thus a priority country in terms of migration.

Overseas remittances of an estimated 118,000 Gambians living abroad is equivalent to over 20 per cent of the country's GDP, while rural-to-urban migration has led to increasing urbanization. Over the past few years, the pursuit for socioeconomic advancement—especially among the youth—has driven many to undertake irregular migration. Over 45 ,000 Gambians arrived in Europe by irregular means between 2014 and 2024 with many others in Africa along the Central Mediterranean Route opting for voluntary return.

In 2018 The EU and The Gambia agreed on a non-binding arrangement on return. The implementation of the readmission arrangement (Good Practices document) was almost immediately suspended by two return moratoria imposed by The Gambia between 2019 and mid-March 2022. To address insufficient cooperation in readmission and return, the Commission proposed restrictive visa measures under Article 25a of the Visa code, which were adopted by the Council in November 2021.

Despite the lift of moratorium in mid-March 2022, the Gambia continued not to cooperate sufficiently on readmission. Given the lack of progress, the EU adopted second step of visa measures (increase of visa fee from 80€ to 120€) in December 2022 .

An intense engagement at technical and political level took place continuously, including within the Joint Working Group under the readmission arrangement and, thanks to improvements in cooperation, the Commission was in the position to propose to lift the second step measures (on 28 September 2023)

Cooperation with The Gambia in preventing and combating irregular migration and trafficking in human beings is good, including through the Common Operational Partnership project against migrant smuggling and trafficking in human beings (implemented by Spain and Germany and with EUR 1.4 million through the Internal Security Fund Police and soon under the Flexible Mechanism NDICI).

SOMALIA

Cooperation on readmission with Somalia has been unsatisfactory and needs to improve. [The annual assessment under Article 25a highlighted Somalia's insufficient cooperation for four consecutive years.] Somalia needs to **accept non-voluntary returns** and take **concrete steps to improve cooperation** on identification, issuance of emergency travel documents and return operations for all types of returns from all Member States.

The **return of people who have no right to stay in the EU is an absolute priority** for the Member States and sends a very clear message of discouragement to those taking the risks and bearing the costs of irregular migration. Return and readmission are critical components of **a functioning and credible migration management system**.

Migration Programming of the EU Delegation to Somalia

Migration is a key aspect of the Somalia Multi-annual Indicative Programme (2021-2027). The EU Emergency Trust Fund for Africa (EUTF) has been a key tool to address the management of mixed migration flows and displacement in Somalia and in the Horn of Africa. As part of the EUTF, the European Union supports programmes with a view to mitigating the effects of displacement and managing mixed migration flows in Somalia. With a total worth of 50 MEUR, the RE-INTEG Programme was launched in 2016 and has financed projects with the aim of supporting the reintegration of refugees, returnees and internally displaced people among host communities by supporting the provision of basic services and strengthening livelihood

With regional EU funding, the regional Better Migration Management (BMM) Programme aims to strengthen the Federal Government of Somalia in pursuing a government approach to migration and border management to effectively address trafficking in persons and smuggling of migrants. The programme also aims to support regional policy harmonisation and cooperation in accordance with the relevant international conventions and standards. The BMM Programme is currently funded by NDICI (but with a more limited budget a more narrow scope of activities in Somalia).

The Regional Durable Solutions Programme has allocated €10 million to the "Xalfoon" Project, which is being implemented by IOM for a project covering South West State and Jubaland State. This initiative will provide early solutions to support recovery among people displaced by the recent drought and ongoing floods, while also assisting displacement-affected communities with longer-term support to improve access to basic services and livelihood opportunities. The project is implemented by the Danwadaag Consortium led by IOM.

The BREACH Programme, €35 million Boosting Resilience and Adaptation to Climate Change (BREACH) Programme will provide €17 million to displacement-affected communities in South West State, Hirshabelle State and Somaliland. The programme also focusses on agricultural development, river basin management and land restoration, with the view to improve conditions in rural areas and prevent floods, which contributes to decreasing the risk of displacement. The durable solutions component of the programme is being implemented by Concern Worldwide in Afgoye (South West State), Norwegian Refugee Council in Jowhar (Hirshabelle State) and World Vision International in Burao (Somaliland) while UN-Habitat will support capacity development of local authorities on sustainable and inclusive urban development in the three locations.

The Sustainable Urban Integration of Displacement-Affected Communities (SUIDAC) regional programme seeks to contribute to addressing protection and long-term needs and support durable solutions for forcibly displaced populations (refugees and IDPs) and host communities. The programme focusses particularly inclusive urban development in African cities and will tentatively allocate €5 million to Somalia as part of a regional contract with Cities Alliance. One or two cities in Somalia need to be identified based on willingness and readiness by the local authorities to work on inclusive urban development planning. The plan is currently to focus on Galmudug State.

The €55 million EU Trust Fund RE-INTEG Programme focusses primarily on achieving durable solutions to displacement and was implemented in all Federal Member States of Somalia (including Somaliland). The implementation of the programme started in 2016 and the action managed to improve access to basic services for close to 400,000 persons and supported more than 11,000 persons with jobs or income-generating activities. The programme was amended to add €5 million to support the response to the COVID-19 pandemic. Most of the projects have ended with the exception of two projects focussing on COVID-19 response.

The Migrant Protection, Return and Reintegration Programme for Sub-Sahara Africa (MPRR-SSA) is a regional EU initiative that supports protection, voluntary return of stranded Somali migrants and reintegration with their home communities. The programme builds on the achievements of the EU-IOM Joint Initiative for Migrant Protection and Reintegration funded by the EUTF and is currently funded through the NDICI budget (but with a more narrow scope of activities in Somalia).

Hashi	COM reiterated its concerns on Somalia’s readmission cooperation and the need for concrete improvement, urging for the official lifting of the moratorium on non-voluntary returns. The Ambassador committed to pass on the message to his superiors and to push for a prompt solution.

B. SOUTHERN MEDITERRANEAN COUNTRIES

MOROCCO

The EU-Morocco Association Agreement entered into force in 2000. A Mobility Partnership was signed in June 2013. Since 2013, the EU supports the implementation of Morocco's National Strategy on Migration and Asylum. The Commission has a mandate to negotiate a readmission agreement since 2000. Negotiations on a readmission agreement have been intensively pursued but ended in a stalemate in 2010. Following the signing of the Mobility Partnership in 2013, the Commission also received a mandate to negotiate a visa facilitation agreement in 2014. A single round of negotiations on both agreements took place in January 2015. Migration and mobility are part of the EU-Morocco Partnership priorities, currently being updated.

After several years of stalemate (within the general freeze of the relations EU-Morocco) the dialogue was formally relaunched in 2019 (Association Council of 27 June 2019). Morocco recognizes Migration and Security as central areas for cooperation with the EU. Morocco has engaged substantially, reducing significantly the flow of irregular migrants arriving to the EU via the Mediterranean Sea. However, irregular arrivals of Moroccans and from Morocco remain high. As of November 2023, Moroccan was the main nationality registered along the Western Mediterranean and Atlantic routes, and Morocco was the main country of departure.

Following the visit of Commissioner Johansson and Commissioner Várhelyi to Rabat (1-2 December 2020) and the SOM on Migration (17-18 March 2022) led by DG Pariat, a new impetus was given to the dialogue and cooperation on migration with Morocco with concrete steps to strengthen cooperation on fight against migrant's smuggling and trafficking in human beings, border management, return and readmission, Talent partnerships, protection and asylum, cooperation with JHA agencies (Frontex, Europol, EUAA), and migration and development. An Anti-smuggling operational partnership was launched by Commissioner Johansson after the tragedy occurred in Melilla in July 2022. Morocco features on the list of priority partners to conclude Working Arrangements with Europol. Further to multiple exchanges and meetings, a study visit of a Moroccan representative at Europol took place in October 2022. The Moroccan authorities agreed to hold the first negotiation round in July 2023, but cancelled the meeting a few days before and, despite repeated attempts at various levels, they have not come forward with a new date as yet. Additionally, the Council has authorised the opening of negotiations with Morocco for an international agreement on the exchange of personal data with Europol as of 2018, but no particular interest has been shown on the Moroccan side and no formal negotiation round has been held.

The EU portfolio on migration with Morocco, reached a total of approximately EUR 360 million under the MFF 2014-2020, out of which around EUR 234 million are drawn from the EU Emergency Trust Fund for Africa-North Africa window. Under NDICI-GE for the period 2021- 2023, an overall amount of approximately EUR 193 million has been allocated to Morocco. This includes a budget support action of EUR 152 million aimed at supporting the National Strategy on Immigration and Asylum (SNIA) and the Operational Strategy Action Plan set out by the Moroccan Ministry of Interior. Morocco also benefits from NDICI-funded regional and bilateral actions on protection, return and reintegration, as well as on legal migration and mobility.

Further actions and related funding are being discussed for Morocco under the Annual Action Plan for Migration in the Southern Neighbourhood for 2024 (overall amount EUR 208 million).

As outlined in the Communication on Attracting Skills and Talent to the EU published on 27 April 2022, Morocco is among the partner countries to be engaged in a Talent Partnership. The first Talent Partnership roundtable occurred on 26 April 2023.

TUNISIA

The EU-Tunisia Association Agreement entered into force in 1998.

A Mobility Partnership was signed on 3 March 2014 between Tunisia and the EU. In this context, the Commission has a mandate to negotiate agreements on Visa Facilitation and Readmission. The latest negotiation round took place in January 2019. Migration and mobility are part of the Strategic Priorities 2018-2020 adopted in November 2018, whose post-2020 version is being negotiated with Member States.

Tunisia signed a Working Arrangement with CEPOL in 2022. A draft Working Arrangement has been with the Tunisian authorities since 2021, despite repeated reminders of Europol and of the EU Delegation. Tunisia is a beneficiary of both regional capacity-building projects CT INFLOW and EUROMED Police, both managed by CEPOL (EUROMED Police is also supported by Europol). Additionally, the Council has authorised the opening of negotiations with Tunisia for an international agreement on the exchange of personal data with Europol as of 2018, but no particular interest has been shown on the Tunisian side and no formal negotiation round has been held.

The EU-Tunisia partnership is based on the Association Agreement, which covers a wide range of domains. Some areas of the partnership have been further operationalised by the implementation of the EU-Tunisia Memorandum of Understanding on a strategic and global partnership signed on 16 July 2023. It aims at strengthening cooperation over five priority pillars (macro-economic stability, economy and trade, green energy transition, people-to-people contacts, and migration and mobility). The migration pillar of the MoU includes EUR 105 million in projects funded from the 2023 budget on migration, building on ongoing programmes and reinforcing areas of mutual interest.

The EUTF support to Tunisia (2016-2021) amounted to around EUR 87 million and focuses on assisting Tunisia in the implementation of joint priorities in the field of migration. These include mobilising Tunisians abroad for investment in the country; providing social and economic assistance to Tunisian returnees through a 'National Mechanism of Reintegration' (Tounesna); supporting young Tunisians prone to migration in regions most affected by emigration; supporting the national governance on migration to have reliable and representative figures on migration dynamics in Tunisia; supporting Tunisia in the development of an Integrated Border Management system; supporting Tunisia in the protection of vulnerable migrants and refugees; and supporting Tunisia in its Labour Migration Governance.

Under NDICI, the EU dedicated to Tunisia around EUR 175 million for the period 2021-2023, focusing on migration programmes in the area of border management, protection and socio-economic integration of Tunisian returnees. As part of this funding, Tunisia also benefits from regional actions in the areas of voluntary returns to countries of origin, legal migration and anti-smuggling.

As outlined in the Communication on Attracting Skills and Talent to the EU published on 27 April 2022, Tunisia is among the priority countries to be engaged for the launching of a Talent Partnership. The first Talent Partnership roundtable took place on the 20th June 2023. The second one took place on 21st June 2024.

ALGERIA

The EU-Algeria Association Agreement entered into force on 1 September 2005. The Commission received a mandate to negotiate a readmission agreement with Algeria in November 2002. No negotiations have so far taken place. Migration and mobility are one of the 5 Partnership priorities adopted in March 2017, currently being renewed.

*Algeria was eligible for funding under the EU Trust Fund for Africa but did not express an interest. In recent engagement, including the **seventh EU-Algeria Informal Dialogue on Migration and Mobility** (July 2023) in 2022, the Algerian authorities have shown renewed interest in cooperation on migration, and in particular triangular cooperation and voluntary returns to sub-Saharan Africa, with the objective of reaching the target of 10 000 returnees per year (up from ca. 2 000 per year currently).*

Algeria features on the list of priority partners to conclude Working Arrangements with Europol and is also covered by a Council mandate to open negotiations concerning an international agreement to exchange personal data with the Agency. However, the country has not expressed any concrete interest in either process.

Algeria is a beneficiary of both regional capacity-building projects CT INFLOW and EUROMED Police, both managed by CEPOL (EUROMED Police is also supported by Europol).

The increase is positively perceived by the main countries of origin such as Guinea, Mali, Niger, Cote d'Ivoire, Burkina Faso, Senegal, through their respective Embassies in Algeria.

During the Dialogue, Algerian authorities also indicated interest for cooperation on counter-smuggling, although with a preference for addressing root causes rather than operational cooperation, and made requests for technical assistance, in particular in view of setting up a national authority in charge of migration management, and on management of reception facilities. Attempts at addressing these other topics and those of interest for the EU side have not yielded results so far.

Algeria did not participate in the International Conference on a Global Alliance to counter migrant smuggling organised by the European Commission on 28 November 2023 in Brussels.

Following trilateral EU-DZ-IOM meetings organized in December 2023 and June 2024, the EU has confirmed its commitment to support IOM in scaling-up voluntary return operations from Algeria to countries of origin to achieve the afore-mentioned target.

EGYPT

Relations between the EU and Egypt are governed by an Association Agreement since 2004. The latest EU- Egypt Partnership Priorities were adopted on 19 June 2022 and include a chapter on the strengthening of bilateral co-operation on migration and mobility. On 16 December 2017, Commissioner Avramopoulos and Egyptian FM Shoukry launched the EU-Egypt Migration Dialogue. The 3rd Migration Dialogue took place in November 2021.

Egypt features on the list of priority partners to conclude Working Arrangements with Europol; negotiations are ongoing and the Agency expects some feedback on a revised text. The country is also covered by a Council mandate to negotiate an international agreement concerning the exchange of personal data with Europol as of 2018, but no particular interest has been shown on the Egyptian side and no formal negotiation round has been held.

Egypt is a beneficiary of the regional capacity-building project EUROMED Police, both managed by CEPOL (EUROMED Police is also supported by Europol).

In recognition of Egypt's key role in the security and stability of the region, the Commission has launched a Strategic and Comprehensive Partnership with Egypt on 17 March, with the signature of the Joint Declaration. This will unleash the full potential of EU-Egypt relations alongside 6 key pillars: (1) political relations; (2) economic stability; (3) trade and investment; (4) migration and mobility; (5) security and (6) demography and human capital. The Strategic and Comprehensive Partnership was presented to President Al-Sisi by the President of the Commission during her visit to Cairo in November 2023. This partnership is accompanied by a financial and investment support package of EUR 7,4 billion from the EU for the next four years (2024-2027) to strengthen the Egyptian economy and foster EU-Egypt cooperation across various sectors. The package consists of up to EUR 5 billion in loans through two Macro-Financial Assistance (MFA) operations; EUR 1.8 billion in additional investments to be mobilised in conjunction with European Financial Institutions under the Economic and Investment Plan; EUR 600 million to support specific priorities under the Partnership through projects and technical assistance, out of which up to EUR 200 million for migration.

In the area of migration, the EU has responded to the Egyptian government calls for more international support through its different funding instruments, in particular, via the EUR 60 million programme "Enhancing the Response to Migration Challenges in Egypt" under the EU Emergency Trust Fund for Africa currently under implementation (total portfolio for Egypt: EUR 91 million).

*Under NDICI, between 2021 and 2023 we have already **allocated EUR 164 million for bilateral migration-related programmes** to support Egypt on protection (EUR 28 million, contracted in 2023), border management (EUR 110 million, of which EUR 23 million signed in 2022 and topped-up in 2023 with EUR 5 million; and EUR 82 still to be contracted), anti-smuggling (EUR 20 million, currently under negotiation), labour migration and mobility (EUR 2 million, already signed in 2023), and sustainable reintegration (EUR 4 million, signed in 2022). Egypt also benefits from allocations under EU-funded multi-country and regional programmes (notably in the area of voluntary returns and reintegration, and legal migration and mobility), for which it is not possible to compute specific country allocations. Therefore, the total amount of funds allocated to Egypt under both bilateral and regional programmes exceeds EUR 164 million.*

Building on ongoing programmes, new programmes will be designed and implemented in Egypt under the EUR 200 million foreseen for the operationalisation of the migration pillar of the Strategic and Comprehensive Partnership. Programmes and projects under this package, will be designed following identification of needs, as well as discussions with our Egyptian counterparts. Funds will come from NDICI and will cover the period from 2024 to 2027. Support will cover all areas of migration, in line with the comprehensive approach.

As outlined in the Communication on Attracting Skills and Talent to the EU published on 27 April 2022,

Egypt is among the priority countries to be engaged for the launching of a Talent Partnership. The first Talent Partnership Roundtable took place on 7 June 2023. A second one is planned to take place in 2024.

LIBYA

The overriding priority of EU action is to contribute to a stable, democratic and united Libya. To this end, the EU supports UN-mediated Libyan-led and Libyan-owned political process, ultimately aimed at holding national elections.

The EU aims to strengthen democracy, the rule of law and legitimate national institutions for a stable, resilient and prosperous Libya. Stabilisation is also a prerequisite for developing a rights-based migration management system in Libya and for the EU-Libya partnership on migration.

Libya is a beneficiary of both regional capacity-building projects CT INFLOW and EUROMED Police, both managed by CEPOL (EUROMED Police is also supported by Europol).

In 2023 Libya was one of the main countries of departure on the Central Mediterranean route (approximately 50.000 irregular arrivals), second only to Tunisia (almost 100.000 irregular arrivals). Between 1 January and 16 June 2024, 14 526 arrivals from Libya to Italy were recorded (compared to 27 863 in the same period in 2023). The Libyan western coast continues to be the primary departure point, closely followed by Tunisia, although there are concerns about a potential resurgence of departures from Libya's East. As of 16 June 2024, there were 4 177 migrants held in MOI-DCIM-managed DCs across Libya.

Since June 2023, a total of 10 751 migrants and persons in need of international protection have been intercepted by Libyan forces at the border with Tunisia (as of 4 July 2024).

The total number of voluntarily humanitarian returns (VHRs) in 2024 so far remains low at 5 111. On 2 July 2024, , in response to intensive advocacy by the EUD, Prime Minister Dbeibah issued Decree No. 323, exempting VHRs from visa fees, which will likely allow to accelerate the procedure and possibly lead to at least 15.000 IOM assisted voluntary returns in 2024.

*Promoting human rights including the human rights of migrants remains a priority. In March 2023 the **Independent Fact-Finding Mission on Libya** presented its final report. The Mission found reasonable grounds to believe that the exploitation of migrants entailed violations of international human rights law and international humanitarian law and the commission of crimes against humanity. The report also came to the conclusion that State affiliated entities in Libya “received technical, logistical, and monetary support from the EU and its MS for inter alia the interception and return of migrants to Libya.”*

*The EU Border Assistance Mission (**EUBAM Libya**) was established in July 2013 as a civilian advisory Mission. In June 2023, the Council extended EUBAM Libya's mandate until 30 June 2025, with a refocus on support to integrated border management, fight against cross-border crime (including trafficking in human beings and migrant smuggling) and counter-terrorism. EUBAM Libya provides technical advice, capacity-building activities at the operational and technical levels and carries out projects, complemented as appropriate and on a case-by-case basis by specialised training. The Mission furthermore provides strategic advice where requested by the Libyan authorities.*

***EUNAVFOR MED IRINI** was launched on 31 March 2020 with the core task to contribute to the implementation of the UN arms embargo on Libya, through the use of aerial, satellite and maritime assets. In particular the mission is mandated to carry out inspections of vessels on the high seas off the Libyan coast suspected to be carrying arms or related material to and from Libya. The mandate also includes the training of the Libyan Coast Guard and Navy in law enforcement tasks at sea and the disruption of the business model of human smuggling and trafficking in human beings networks. In March 2023 the Council extended the mandate of EUNAVFOR MED IRINI until 31 March 2025.*

Libya was the biggest beneficiary of the EUTF-NoA, with EUR 465 million. Over half of the funding went to the protection of migrants and refugees, their evacuation and humanitarian return; one third

to community stabilisation in Libyan municipalities; the rest of the funds was allocated to programmes in the area of border management.

Under the new NDICI-Global Europe (2021-2027), Libya is profiting from bilateral and regional actions, adopted between 2021 and 2023, amounting to at least EUR 100 million, including in the area of protection, supporting return and reintegration as well as border management institutions.

Further actions and related funding are being discussed for Libya under the Annual Action Plan for Migration in the Southern Neighbourhood for 2024 (overall amount EUR 208 million).

JORDAN

Relations between the EU and Jordan are governed by an Association Agreement which entered into force in 2002. On 12 December 2012, the EU and Jordan launched a Dialogue on Migration, Mobility and Security. On 9 October 2014, the EU and Jordan signed a Mobility Partnership. First bilateral discussions on visa facilitation and readmission took place in November 2016, but were afterwards put on hold by the Jordanian side, mainly due to concerns over third country nationals' clause in the readmission agreement. The EU—Jordan Partnership Priorities 2021-2027 text (including migration and mobility) has been adopted at the 2 June 2022 EU-Jordan Association Council.

Jordan features on the list of priority partners to conclude Working Arrangements with Europol; negotiations are ongoing and it is hoped to conclude them soon. The country is also covered by a Council mandate to negotiate an international agreement concerning the exchange of personal data with Europol as of 2018, but no particular interest has been shown on the Jordanian side and no formal negotiation round has been held.

Jordan is a beneficiary of both regional capacity-building projects EUROMED Police and CT INFLOW, both managed by CEPOL (EUROMED Police is also supported by Europol).

On 27 May, during the eighth edition of the Brussels Conference on 'Supporting the future of Syria and the region' hosted by the European Union, the donor community pledged a total amount of €7.5 billion. This strong commitment shows once more the willingness of the EU and the international community to mitigate the impact of the Syrian crisis; and support the populations both in Syria and in neighbouring countries. The total amount of pledges includes €5 billion of grants and €2.5 billion of loans for 2024 and beyond. The overall figure includes the €2.12 billion pledged by the EU for 2024 and 2025, announced during the conference by High Representative for Foreign Affairs and Security Policy/Vice-President of the European Commission, Josep Borrell. The total amount pledged by the EU and its Member States amounted to almost €6 billion, reaffirming them as the largest donor to the Syria response.

LEBANON

Relations between the EU and Lebanon are governed by an Association Agreement signed in June 2002 (entered into force in April 2006). On 10 December 2014, the EU and Lebanon launched a Dialogue on Migration, Mobility and Security. In 2016, the EU and Lebanon adopted the Partnership Priorities for the period 2016-2020 (extended until new ones are signed), migration and mobility being one of them. Lebanon is in a presidential vacuum since October 2023 and with a government in a caretaking capacity since May 2022.

Lebanon features on the list of priority partners to conclude Working Arrangements with Europol and is also covered by a Council mandate to open negotiations concerning an international agreement to exchange personal data with the Agency. However, the country has not expressed any concrete interest in either process. Lebanon is a beneficiary of both regional capacity-building projects CT INFLOW and EUROMED Police, both managed by CEPOL (EUROMED Police is also supported by Europol).

Lebanon expressed in May 2019 an interest in starting the negotiations for a Visa facilitation agreement. In the autumn 2019, there were signals that Lebanon would be willing to relaunch the negotiations on the Mobility Partnership, but no concrete follow-up steps have been taken by Lebanon so far (also due to the deteriorating political, financial, economic and social crisis, exacerbated by the 2020 explosion in the port of Beirut and the COVID-19 pandemic, followed by a power vacuum in 2022 – no government formed since the 15 May parliamentary elections and president not elected since the expiration of the mandate on 31 October).

At the Brussels VII Conference on Supporting the future of Syria and the region held in June 2023, hosted by the EU, pledges for both, Syria and the region close to EUR 4.57 billion for 2023 and multi year pledges of close to EUR 1 billion for 2024 and beyond. Since the start of the conflict in 2011, the EU and its Member States have mobilised over 30 billion to help those affected by the Syrian conflict. This makes the EU collectively the largest provider of international aid in response to the Syria crisis, delivering humanitarian, stabilisation and resilience assistance inside Syria and in neighbouring countries. On 27 May, during the eighth edition of the Brussels Conference on 'Supporting the future of Syria and the region' hosted by the European Union, the donor community pledged a total amount of €7.5 billion. This strong commitment shows once more the willingness of the EU and the international community to mitigate the impact of the Syrian crisis; and support the populations both in Syria and in neighbouring countries.

The total amount of pledges includes €5 billion of grants and €2.5 billion of loans for 2024 and beyond.

The overall figure includes the **€2.12 billion pledged by the EU for 2024 and 2025**, announced during the conference by High Representative for Foreign Affairs and Security Policy/Vice-President of the European Commission, Josep Borrell. **The total amount pledged by the EU and its Member States amounted to almost €6 billion**, reaffirming them as the largest donor to the Syria response.

During a visit to Lebanon on 2 July 2024, President von der Leyen announced a 1 billion financial support package for the country (following up to the 17-18 April Council conclusions).

This support will be designed to improve the overall economic situation of the country, including on basic services such as education, social protection and health, and supporting the most vulnerable people in Lebanon, including refugees, internally displaced persons and host communities; as well as to strengthen cooperation on migration-related challenges, integrated border management, including anti-smuggling and trafficking in human beings, and security.

The package will be adopted in two parts: the first, of half a billion euros, in July 2024, and the second at a later stage, taking into account progress on necessary reforms and the overall situation in the country.

C. WESTERN BALKANS

Cooperation with all Western Balkan partners remains a top political priority for the EU, as i.e. demonstrated by the EU-Western Balkan Summit Declaration adopted on 13 December 2023. The declaration specifically also mentions that migration management remains a joint challenge and responsibility, which the EU and Western Balkan Partners will continue to address together, in line with the EU Action Plan on Western Balkans presented by the Commission in December 2022. All partners enjoy a visa-free regime with the EU.

The Western Balkan region mainly serves as a transit route for migrants and victims of trafficking. Partnership with the Western Balkans is a good example of the comprehensive approach to migration management as set out in the New Pact. Through the support of the JHA Agencies and with significant financial and technical assistance, the EU is working closely with partners in the region in the area of asylum and reception, visa policy alignment, border management, return and readmission, migrant smuggling, trafficking in human beings, and sharing of information. The implementation of the EU Action Plan on Western Balkans has delivered significant results, since the number of irregular border crossings to the EU via the Western Balkan route decreased by 30% in 2023 compared to 2022. This decrease further accelerated in the first five months of 2024, with -70% of irregular border crossings from this route.

There are bilateral Justice and Home Affairs subcommittee meetings and Joint Readmission Committees with Western Balkan partners. There are also yearly regional meetings on Home Affairs at Senior Officials' and Commissioner's levels. From 2007-2020, the EU has provided assistance to the Western Balkans in the area of migration for a total of EUR 492.75 million, channelled through the Instrument of Pre-accession Assistance (IPA) and the EU Regional Trust Fund in Response to the Syrian Crisis (EUR 450.15 million), as well as humanitarian aid (EUR 42.6 million). Overall, total migration support to the Western Balkans adopted so far under IPA III (2021-2023) amounts to €291.9 million. with further plans to increase this amount in 2024 to EUR 350 million, including the recently adopted 13 million regional project on returns.

ALBANIA

Albania formally agreed an association with the EU by signing a Stabilisation and Association Agreement in 2006 (entry into force in 2009). Albania was awarded candidate status in 2014. The accession negotiations were opened in 2020 and launched in July 2022 with the first Inter-governmental Conference.

Albania has agreements or arrangements signed with the European Border and Coast Guard Agency (Frontex) (Status Agreement signed in 2023 (to replace previous SA from 2019);) with teams currently deployed at Greek border, along the Adriatic, and at border crossing with Montenegro, Europol (2013), CEPOL (2013), the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA) (2019), and a Roadmap with the European Union Asylum Agency, and has signed the 2019 Joint Action Plan on Counter-Terrorism for the Western Balkans, whose implementing arrangement was revised in December 2022. BOSNIA AND HERZEGOVINA

Bosnia and Herzegovina's Stabilisation and Association Agreement with the EU entered into force in June 2015 and the country applied for EU membership in February 2016. The European Council granted the status of EU candidate country to Bosnia and Herzegovina on 15 December 2022, and on 21 March 2024 decided to open EU accession negotiations with Bosnia and Herzegovina. The European Council invited the Commission to prepare the negotiating framework with a view to its adoption by the Council the moment all relevant steps set out in the Commission's recommendation of 12 October 2022 are taken. Among these steps, Bosnia and Herzegovina needs to decisively advance work to ensure effective coordination, at all levels, of border management and migration management capacity, as well as ensuring the functioning of the asylum system. Significant financial support has been provided to the country to strengthen the response capacity to manage migration flows.

Negotiations for a Frontex Status Agreement with the EU started in May 2024, after it was authorized by the Council in 2022. A Working Arrangement with Frontex on operational cooperation was signed in 2009. Bosnia and Herzegovina concluded an Agreement on Operational and Strategic Co-operation with Europol (2016) and a Working Arrangement with CEPOL (2014). The country is a beneficiary of the regional capacity-building project WB PaCT, managed by CEPOL and supported by Europol. In January 2021, the European Union Agency for Asylum (EUAA) agreed on a roadmap with Bosnia and Herzegovina, with the overall objective of enhancing the protection space for asylum seekers in Bosnia, thus aligning it in with the EU Common European Asylum System. EUAA 2nd generation Roadmap for cooperation is being finalized. Bosnia and Herzegovina signed the 2019 Joint Action Plan on Counter-Terrorism for the Western Balkans. A new reception and identification centre opened in Lipa on 19 November 2021.

The sixth report under the Visa Suspension Mechanism adopted in October 2023 confirmed that Bosnia and Herzegovina has taken actions identified in the Fifth Report and the visa liberalisation benchmarks continue to be fulfilled.

NORTH MACEDONIA

North Macedonia formally agreed an association with the EU through the Stabilisation and Association Agreement, which entered into force in 2004. It applied for EU membership in 2004 and the Council decided in December 2005 to grant the country candidate status. In March 2020, the General Affairs Council decided to open accession negotiations under the revised methodology. In July 2020 the draft negotiating framework was presented to the Member States.

North Macedonia concluded agreements or arrangements with the European Border and Coast Guard Agency (Frontex) (2009 working arrangement and 2022 status agreement, operational since April 2023), Europol (2011), CEPOL (2017) and signed the 2019 Joint Action Plan on Counter-Terrorism for the Western Balkans. The country is a beneficiary of the regional capacity-building project WB PaCT, managed by CEPOL and supported by Europol. On 26 October 2022, the EU and North Macedonia signed a Frontex Status Agreement. North Macedonia has a Joint Roadmap with the EUAA, to support the further development of a national asylum and reception system in line with EU standards in place.

MONTENEGRO

Montenegro formally agreed an association with the EU by signing a Stabilisation and Association Agreement in 2007 and was awarded candidate status in 2010. The accession negotiations started in 2012 and to date 33 negotiating chapters have been opened (including Chapter 24 on Justice, freedom and security) of which three have been provisionally closed. Sub-Committees on Justice, Freedom and Security take place, in principle, annually. An Intergovernmental Conference (IGC) took place on 26 June 2024 June with Montenegro, on the basis of the Interim Benchmarks Assessment Reports (IBARs) prepared by the Commission relating to chapters 23 and 24 of the acquis.

The Commission IBARs concluded that Montenegro has overall met the interim benchmarks set in the European Union Common Positions (CONF-ME 13) for Chapters 23 and 24, while some have been only partially met. Based on this assessment, the Council adopted EU Common Positions for chapters 23 and 24 that set closing benchmarks and provide further guidance for the work ahead. Building on the current momentum on enlargement, the objective is to move Montenegro to the next phase of accession negotiations, in which negotiating chapters may be provisionally closed.

Montenegro concluded agreements or arrangements with the European Border and Coast Guard Agency (Frontex) (2019 Status agreement; new agreement signed on 16 May 2023) with teams deployed at EU borders, Europol (2014), and CEPOL (2011), and signed the 2019 Joint Action Plan on Counter-Terrorism for the Western Balkans and a 2021 Joint Roadmap for cooperation with the EUAA. The country is a beneficiary of the regional capacity-building project WB PaCT, managed by CEPOL and supported by Europol. In 2023 Montenegro made the request to sign a Working Arrangement with the ECMDDA that should be finalised in 2024.

The sixth report under the Visa Suspension Mechanism adopted in October 2023 confirmed that Montenegro has taken actions identified in the Fifth Report and the visa liberalisation benchmarks continue to be fulfilled. Montenegro has observer status in the European Migration Network.

SERBIA

In March 2012 Serbia was granted EU candidate status. In September 2013 a Stabilisation and Association Agreement between the EU and Serbia entered into force. 18 out of 35 negotiating chapters have been opened, including, “Judiciary and fundamental rights” (so-called chapter 23) and “Justice, freedom and security” (so-called chapter 24) since the start of accession negotiations with Serbia in January 2014. The first inter-governmental conference with Serbia under this revised methodology agreed by the Council in May 2021, was held on 22 June 2021. Member States decided that no new clusters should be opened. Serbia has Working Arrangements in place with Frontex (2009)), CEPOL (2017) and EMCDDA (2020). The country is a beneficiary of the regional capacity-building project WB PaCT, managed by CEPOL and supported by Europol. An Agreement on Operational and Strategic Cooperation with Europol was signed in 2014. A new Status Agreement with the EU, allowing the European Border and Coast Guard Agency (Frontex) to deploy personnel to Serbia’s borders with its neighbouring Western Balkans partners, in addition to the country's border with the European Union, was signed on 25 June 2024. Serbia has a Joint Roadmap with EUAA in place to support the further development of a national asylum and reception system in line with EU standards.

The sixth report under the Visa Suspension Mechanism adopted in October 2023 confirmed that Serbia had taken actions identified in the fifth Report, but had to continue its efforts in view of full alignment to EU visa policies, had to swiftly finalise the negotiations of the Frontex Status Agreement and to fully implement the third country nationals provision of the EU-Serbia Readmission Agreement.

Serbia was granted observer status in the European Migration Network in March 2023.

KOSOVO

Kosovo formally agreed an association with the EU by signing a Stabilisation and Association Agreement which entered into force in 2015. Kosovo is a potential candidate. In 2018, the Commission confirmed that Kosovo had fulfilled all outstanding visa liberalisation benchmarks. On 18 December 2022, CZ PCY and EP reached an agreement on visa free travel for Kosovo. The final vote in EP took place on 18 April. The visa free regime for Kosovo passport holders entered into force on 1 January 2024.*

Kosovo has Working Arrangements with EBCGA (Frontex) since 2016, Europol (2020), CEPOL (2017) and EMCDDA (2020). The country is a beneficiary of the regional capacity-building project WB PaCT, managed by CEPOL and supported by Europol. Kosovo has a Joint Roadmap with EUAA in place since March 2022. EU measures vis-à-vis Kosovo, imposed due to Kosovo's failure to de-escalate the situation in the north of Kosovo and to return to the process of normalisation of relations with Serbia, have remained in place. Due to those measures, no new assistance has been programmed for Kosovo in 2023.

TÜRKIYE

In 2008 the Council adopted a revised Accession Partnership with Türkiye. On 16 December 2013 the EU and Türkiye signed a readmission agreement and launched a visa liberalisation dialogue. The Commission adopted the first report on the implementation of the Visa liberalisation roadmap on 20 October 2014. Türkiye continued to develop its administrative capacity to implement the re-admission agreement, which entered into force for Turkish nationals in October 2014. Regarding the readmission of third country nationals, the relevant provisions entered into force on 1 June 2016. Nevertheless, so far the Turkish Council of Ministers has not taken the decisions authorising the application of these provisions.

A Strategic Agreement, not enabling the exchange of personal data, is in force with Europol and so is a Cooperation Agreement with CEPOL. Additionally, the Council has authorised the opening of negotiations with Türkiye for an international agreement on the exchange of personal data with Europol as of 2018. Four negotiation rounds have been held, the latter in 2021, and a mature text has been produced with small open points, but the agreement cannot proceed pending the revision of Türkiye's national data protection legislation to the extent it concerns the safeguards under the Agreement.

The meeting of Heads of State or Government with Türkiye on 29 November 2015 activated the Joint Action Plan on Migration in order to step up cooperation for the support of Syrian refugees under temporary protection and their host communities in Türkiye and to strengthen cooperation to prevent irregular migration flows to the EU. A comprehensive cooperation based on shared responsibility, mutual commitments and delivery between the European Union and Türkiye was agreed within the framework of the 18 March 2016 EU- Turkey Statement.

In response to the call from EU Member States for significant additional funding to support refugees in Türkiye, the Commission established on 24 November 2015 the Facility for Refugees in Türkiye. The Facility is a mechanism that coordinates the mobilisation of resources made available under both the EU budget, and additional contributions from Member States integrated into the EU budget as external assigned revenue. Contributions amount to a total of EUR 6 billion, with EUR 3 billion committed for the years 2016-2017 and a further EUR 3 billion committed for 2018-2019. Both tranches combined, all operational funds have been committed and contracted, with just over to EUR 5 billion disbursed. In 2020 an additional EUR 535 million were committed to ensure the continuation of two flagship Facility interventions (basic needs and access to education). This comes on top of the Facility's EUR 6 billion. In June 2021, the European Council confirmed its commitment to continue supporting refugees and host communities in Türkiye. The Commission is finalising the preparation of the 2021-2023 EUR 3 billion package to be financed by the EU budget. 1 billion EUR was already allocated in 2021 (of which 325 million will be provided for the continuation of the Emergency Social Safety Net (ESSN), 530 million EUR to education, and 30 million EUR to the improvement of migration management), and in 2022, another EUR 1 235 million were committed in the priority areas of basic needs and socio-economic support (EUR 634 million), as well as border management (EUR 220 million). The balance of this package was being programmed in 2023 (barring the adoption of a EUR 14.4 million Support Measure, to be adopted in early 2024), going towards the areas of health (EUR 210 million), as well as post-earthquake support in the areas of socio-economic support and infrastructure services (EUR 240 million), and health and education infrastructure (EUR 115.6 million). Overall, the new 2021-2023 funding package is intended to gradually move away from humanitarian assistance to long-term livelihood support and gradual disengagement, pending the final restoration of national ownership.

Following the June 2021 European Council Conclusions, a High-Level Dialogue on Migration and Security took place on 12 October 2021 in Ankara. On 25 November 2021, a High-Level Dialogue on Counterterrorism at senior officials' level took place in Brussels, facilitating a discussion on security threats related to irregular migration, specifically in relation to the deteriorating situation in Afghanistan and the enduring migratory pressures, alongside the financing of terrorist activities through human smuggling and trafficking in human beings operations.

The continued implementation of the 18 March 2016 EU-Turkey Statement, which reduces irregular and dangerous crossings and saves lives in the Aegean Sea, plays a key role in ensuring that the migration challenge is addressed effectively and jointly by the EU and Türkiye, is in the interest of both sides and remains crucial with a view to saving lives and preventing irregular migration to the EU.

On 23 November 2023, the EU Commissioner for Home Affairs Ylva Johansson and the Minister of Interior of the Republic of Türkiye Ali Yerlikaya met in Brussels for the second Türkiye-EU High Level Dialogue on Migration and Security. They exchanged views on their respective policies and actions related to the prevention of irregular migration and discussed common approaches on a number of issues, including border security and the fight against migrant smuggling. They also looked at how to enhance the cooperation of their respective migration and law enforcement Agencies. Parties agreed to meet at the level of technical and senior officials regularly to review the progress on cooperation on the shared interests in the fields of migration and security.

*Following the devastating earthquakes on 6 February 2023, the European Commission and the Swedish Presidency of the Council of the EU co-hosted an **International Donors' Conference for the earthquake-affected populations of Türkiye and Syria, for which the EU pledged EUR 1 billion for Türkiye.** Negotiations are ongoing with the Turkish authorities to provide humanitarian and development assistance to refugees and host communities in the affected regions. As part of this pledge, the Commission mobilised **EUR 355.6 million of the refugee package** (originally planned for socio-economic support and social cohesion) to support refugees and host communities in the earthquake affected regions as well as further humanitarian assistance of over **EUR 100 million.***

D. ASIAN COUNTRIES

CHINA

The EU-China comprehensive strategic partnership came into force in 2003. China signed an Approved Destination Status Agreement in 2004, facilitating the entry of Chinese tourists into EU Member States and including provisions on readmission. Formal negotiation of an EU readmission agreement, based on 2002 negotiating directives, has not started yet. Negotiation of a PCA, including an article on readmission and visa cooperation, started in 2007.

A Strategic Agreement, not enabling the exchange of personal data, is in force with Europol.

At the 14th EU-China Summit in February 2012 both sides agreed to explore the possibilities of facilitating mobility for Chinese and EU citizens, and strengthen cooperation on illegal immigration, as well as to pay special attention to the question of mutual visa exemption for holders of diplomatic passports. At the 16th EU-China Summit (20-21 November 2013), shared commitments were taken to reinforce the objectives in the 2020 Agenda. Following that, a Roadmap, which consists of a two-stage approach, was finalised during the 2nd meeting of the EU-China Migration and Mobility Dialogue (Beijing, 9 April 2015). The first stage of the Roadmap, which comprises the signature of the EU-China short stay visa waiver for holders of diplomatic passports, the permission for EU Member States to open Visa Application Centres in 15 Chinese cities and the first Expert meeting held in Beijing on 5 November 2015, is considered finalised. The implementation of the 2nd phase of the roadmap is currently on-going. It involves parallel negotiations on: A visa facilitation agreement (VFA) covering holders of other types of passports (including ordinary passports). This also includes discussions on China allowing EU Member States to open further Visa Application Centres (VACs) in additional Chinese cities; and an agreement on cooperation in combating illegal migration (CIMA – including provisions on readmission in line with the EU mandate).

INDIA

The EU-India Co-operation Agreement entered into force in 1994. In 2004 the EU and India established a Strategic Partnership. The EU-India Joint Action Plan was agreed in 2005 at the Summit in The Hague and revised in 2008 at the eighth EU-India Summit in Marseille. This plan aims to promote among others people-to-people contacts and cultural exchanges. After the first EU-India migration dialogue meeting held in 2006, the December 2010 EU-India Summit emphasised the importance of movement of people, and agreed to deepen cooperation by establishing a regular, comprehensive and structured dialogue on migration issues.

India and Europol signed a Working Arrangement in March 2023; and they are now negotiating the implementing instruments (MoU on SIENA connection and Liaison Agreement).

The 2012 EU-India Summit discussed possible ways to facilitate mobility – a recurring Indian request in parallel with preventing and combating irregular migration. A Common Agenda on Migration and Mobility (CAMM) was signed and subsequently endorsed at the 2016 EU-India Summit. CAMM implementation is referred to in the EU-India Agenda for Action-2020, also endorsed at 2016 Summit as well as in the EU-India Roadmap 2025, endorsed at the 2020 EU-India Summit. The EU-India Leaders' Meeting in Porto on 8 May 2021 confirmed the commitment for close and comprehensive cooperation from both sides on all pillars of the CAMM and the continued engagement under the High-Level Dialogue on Migration and Mobility. A project implemented by ILO and ICMPD supported the CAMM/HLDMM from 2017 to 2022; a second phase was launched in October 2023. India continues to express a high level of interest in strengthening cooperation with the EU on legal migration and labour mobility.

Indian citizens enjoyed visa freedom to Serbia until the end of 2022, and used this route (especially via Belgrade Airport) to enter the EU irregularly. Throughout 2022, thousands of Indian citizens filed asylum applications in the EU (mainly in Austria). At EU level, there are currently no plans to engage in any new discussions on formal visa facilitation agreements with third countries, but the Government of India is increasingly requesting facilitations for students and businesspersons due to lengthy visa processing delays at MS consulates in India. NB: India concluded bilateral agreements on migration and mobility with France, Portugal, Germany, Austria, Denmark and Italy. Further, BENELUX and EL confirmed being in active negotiations with India on similar texts, and discussion are ongoing also with FI, CY and SE. Most EU Member States already grant visa-free access to Indian diplomats, notable exceptions being the Benelux countries.

BANGLADESH

The EU-Bangladesh Standard Operating Procedures for the Identification and Return of Persons without an Authorisation to Stay (SOPs) was signed on 20 September 2017. To support capacity to implement the SOPs, DG HOME started in July 2018 a project under the Readmission Capacity Building Facility (RCBF, EUR 4.8 million) aiming at developing a Returnee Case Management System (RCMS) in Bangladesh and deploying an AFIS (Automated Fingerprint Identification System) to enable search by fingerprints in the copy of the Machine-Readable Passport database owned by the Special Branch Police. The pilot phase was launched on 9 November 2020. Six Joint Working Groups on the implementation of the SOPs with Bangladesh have taken place to date. The sustainable reintegration of returnees is supported through the PROTTASHA II project, which aims to facilitate *orderly, safe, regular and responsible migration and mobility of people, including through the implementation of planned and well-managed policies*.

Bangladesh has been providing assistance with the support of the EU, international community and humanitarian and development organisations to the Rohingya refugees, who fled violence in Myanmar in 2017. While Bangladesh recognises in principle that the conditions in Myanmar currently do not allow for a safe and dignified return of Rohingya refugees to Myanmar, the Bangladeshi government increasingly asks for support for their return as soon as possible. The Bangladeshi government has closed the border to Myanmar for any new arrivals, despite recurring escalations of violence resulting in Rohingya community members trying to cross into Bangladesh.

During her visit to Dhaka in November 2022, Commissioner Johansson discussed strengthening cooperation on all aspects of migration management with the Bangladeshi authorities and both sides reaffirmed their commitment to countering irregular migration and migrant smuggling and continuing enhanced cooperation on return and reintegration of Bangladeshi nationals.

As outlined in the Communication on Attracting Skills and Talent to the EU published on 27 April 2022, the Commission has started assessing the feasibility of launching a Talent Partnership with Bangladesh, as one of the key components of a reinforced migration management cooperation with this country. During Commissioner Johansson visit to Bangladesh in November 2022, it was agreed that an informal migration and mobility dialogue would be launched with Bangladesh and the Talent Partnership would be a component. 7 JWG, two Migration and Mobility Dialogues and two Talent Partnership roundtables have taken place so far. In early July 2024, the EU launched the first EU-Bangladesh Talent Partnership contract (EUR 3 million, implemented by the International Labour Organisation).

PAKISTAN

Pakistan is a major country of origin, transit and destination of refugees and migrants. Under the Strategic Engagement Plan of 2019, Pakistan and the EU have agreed to launch a comprehensive EU-Pakistan Migration Dialogue. Following the visit of Commissioner Johansson to Pakistan on 13-14 November 2022, the first meeting of the Informal Migration and Mobility Dialogue took place on 15 March 2023 in Islamabad. The Dialogue was organised back-to-back with the 14th Joint Readmission Committee, a regular annual meeting focusing on the implementation of the EU-Pakistan Readmission Agreement, as well as with the first Talent Partnership roundtable. The latest series of those meetings took place from 23-25 April 2024 in Brussels. These meetings are complemented by interactions at regional level through the Budapest Process, as well as bilateral meetings at technical level with Pakistani partners by representatives of EU institutions but also from EU Member States. In April 2024, Pakistan formally approved the deployment of a FRONTEX liaison officer who will be placed at the EU Delegation in Islamabad (recruitment ongoing).

The full and effective implementation of the Readmission Agreement remains a priority. Ensuring protection space in Pakistan and support for Afghan refugees and host communities in the country, addressing the root causes of irregular migration and forced displacement, reducing further arrivals of irregular migrants, strengthening migration governance, border management, countering migrant smuggling and opportunities for legal migration through talent partnerships (a major interest of Pakistan) are areas to continue to be addressed. To note, that Pakistan reacted very positively to the call to action on a Global Alliance to Counter Migrant Smuggling sending and was represented (as the only country from Asia) at Foreign Minister level at the conference in Brussels on 28 November 2023.

At the same time, migration-related cooperation with Pakistan cannot be isolated from the regional dimension of Afghan displacement and cooperation with Afghanistan and Iran. Since October 2023, Pakistan has aggravated the situation of displaced Afghans by launching a major operation against illegal migrants targeting primarily Afghan nationals within an “Illegal Foreigners Repatriation Plan”. (IFRP). Until the end of June 2024 more than 647,000 Afghans crossed the border back to Afghanistan. Even if these returns are labelled in the majority of the cases as “voluntary”, UN agencies report that most of the people interviewed testify experiencing harassment, detention or being otherwise incited to leave Pakistan. According to UNHCR 99% of the problems were experienced on the Pakistani side of the border. Border crossing statistics show a slow but steady increase in these returns since January 2024, after a spike in November followed by a sharp decrease. . In June 2024, IOM reported more than 31,000 Afghans returning from Pakistan but numbers of crossings remain low. In July 2024 the Pakistani government announced that (upon request from UNHCR) it will continue with the pause in repatriation and that recently expired Proof of Registration Cards issued to Afghan nationals will be extended by another 1,5 year (until the end of 2025). In line with EU Council Conclusions on Afghanistan from September 2021 and March 2023, the EU has mobilized substantial assistance to help returnees on the Afghanistan side of the border [see the table on Afghanistan]. The EU continued to actively reach out to Pakistani authorities directly and called publically on Pakistan to suspend the execution of the IFRP. It has made also clear in all communications that the assistance mobilized is not meant to help implement the Pakistani Plan but only to provide humanitarian assistance to the displaced returnees.

As outlined in the Communication on Attracting Skills and Talent to the EU published on 27 April 2022, the Commission started assessing the feasibility of launching a Talent Partnership with Pakistan as one of the key components of a reinforced migration management cooperation with this country. Work towards the development of a Talent Partnership with Pakistan is advancing, through regular discussions at the technical level. . The latest Talent Partnership roundtable took place on 23 April 2024. The first Talent Partnership contract, to be implemented by the German GIZ, is currently under negotiation and expected to be finalised by the end of summer 2024.

An Action Plan on Pakistan was elaborated and discussed in the respective EMWP meetings in June and July 2022. The subsequent discussions about the Action Plan on Pakistan continued in 2023.

AFGHANISTAN

Since 2016, the EU has been engaged with Afghanistan in a constructive dialogue on migration and forced displacement, with the aim to build a long-term partnership in this area in a spirit of solidarity. This balanced and comprehensive cooperation on migration was reflected in the Joint Way Forward (JWF) and its successor arrangement entitled 'Joint Declaration on Migration Cooperation (JDMC- signed on 26 April 2021) which built on the JWF and consolidated the already very good EU-Afghan cooperation on migration governance by adapting it to the migratory situation in 2021. These documents had been instrumental in allowing Afghans residing irregularly in the EU to return in a safe, dignified and orderly way, and in reintegrating them in Afghanistan. Since the takeover of Afghanistan by the Taliban in August 2021, this arrangement is on hold. While any decision on returns is the competence of EU Member States within the limits imposed by EU law, carrying out returns remains extremely difficult, in the current circumstances where human rights in Afghanistan are systematically abused.

From the beginning of the crisis in mid-August 2021, the Commission and the EEAS put in place a set of priority actions :

1. Safe evacuation and passage of EU nationals from Afghanistan, as well as of those Afghans and their families who have worked for the EU and for its Member States;
2. Ensure safe and legal pathways for Afghans in need of immediate protection, with a strong gender dimension. Building on the Resettlement Forum of July 2021, Commissioner Johannsson repeatedly called on EU Member States to step up their engagement on resettlement, increase their quotas and consider other complementary pathways to ensure the highest possible number of legal admissions of Afghan refugees, notably women and children.
3. On 7 October 2021, Commissioner Johannsson and High Representative Vice-President Josep Borrell convened a High-level Forum on providing protection to Afghans at risk dedicated to taking stock of the EU Member States' intentions as regards providing protection to the various categories of people at risk in Afghanistan and the neighbouring countries. In addition, a specific, multi-annual Support Scheme for Afghans was announced with the aim to combine short-term measures, notably evacuations/safe passage, and more medium- and long-term measures, including resettlement from neighbouring countries (based on referrals from UNHCR, e.g. from Iran and Pakistan), humanitarian admissions, and other complementary pathways (family reunification and pathways linked to study or work). For 2022, Member States committed 38,000 pledges for humanitarian admissions (as of November 2022, 41 000 humanitarian admission arrivals of Afghan nationals were reported) and 1,111 for resettlement. Furthermore, 13 000 places for Afghans at risk in 2023 were pledged by 16 Member States. Under the current EU resettlement and humanitarian admission scheme for 2024-2025, 8 Member States made specific pledges for Afghans. In total, MS pledged 29 310 places, of which 2 910 for resettlement (9% of total resettlement pledge) and 26 400 for humanitarian admission.
4. Continue supporting the neighbouring countries to Afghanistan and countries of transit in their efforts to provide protection, safe and dignified reception conditions for displaced Afghans and to support the host communities. Continuation of ongoing EU programmes and strengthening cooperation, including on capacity building for host communities in Pakistan, Iran and Tajikistan, as well as other countries in the region, to prevent the unsafe and irregular movements of people, to strengthen border management with the support of Frontex and support protection systems, further reinforce existing programmes on law enforcement cooperation to counter migrant smuggling and trafficking in human beings networks, with the support of Europol. In close co-operation with UNHCR and IOM, the new regional Team Europe Initiative has so far generated 1.1 billion euros in indicative financial allocations and aims to support Afghan IDPs and host communities through policy dialogue, protection (including social

inclusion and sustainable reintegration), provision of basic services, job creation and access to the labour market.

5. *The Regional Team Europe Initiative on the Afghan displacement situation put forward by the Commission is the EU's response to the Afghan regional displacement crisis. It links to the Support Platform for the Solution Strategy for Afghan refugees SSAR project run by UNHCR, and covers Afghanistan, Pakistan, Iran and Central Asian countries. In full compliance with the Council Conclusions of 21 September 2021 and March 2023, EU and Member States support protection, improve livelihood conditions and provide durable solutions for displaced Afghans and their host communities. The TEI also supports better migration management and fight against trafficking in human beings and smuggling of migrants, thus contributing to the operationalization of the external dimension of the EU Pact on Migration and Asylum in countries of primary relevance for the EU. The Regional TEI gathers humanitarian and development actors from EU Services (DG INTPA as well as ECHO and HOME) and 12 EU Member States.*

6. *Enhanced political outreach and dialogue and further strengthening the international community's response on Afghan displacement is also carried out through the Core Group of the Support Platform for the Solution Strategy for Afghan refugees (SSAR). The EU has used its lead role as chair of this Group in this respect in 2021 and 2022, followed in 2023 by Qatar and the Netherlands as the Chair and co-Chair. To note, that - since October 2023 - the EU has been also actively engaged in providing assistance to Afghans returning to Afghanistan from Pakistan in the framework of the Pakistani "Illegal Foreigners Repatriation Plan" [see the table on Pakistan for more details]. DG ECHO mobilised EUR 61 million to assist the returnees (EUR 60 million directed to the Afghan side of the border and EUR 1 million to assist on the Pakistani side of the border).*

IRAN

In February 2019, the Council adopted the text of the Framework for a Comprehensive Dialogue Between the Islamic Republic of Iran and the European Union on Migration and Refugee Issues, i.e. the terms for reference for a migration dialogue. The document was endorsed during the EU-Iran High Level Dialogue of December 2020 (not yet signed). The EU side has repeatedly approached the Iranian side, and also at a high level, with the proposal of holding the first meeting of the dialogue at senior official level, however up till now, the dialogue has not been launched. Given the wider political context, it seems unlikely that the Dialogue would be launched in a foreseeable future. However, the EU will observe if the new reformist government intends to re-engage on bilateral relations and offer some concrete opportunities.

IRAQ

Four meetings under the informal Migration Dialogue took place in 2017, 2018, 2019 and 2021 respectively, discussions comprised irregular migration and return, migration governance and migration and development. The 2022 meeting of the informal dialogue could not take place due to general elections and a political deadlock in the government formation process. The 19 March 2023 EU-Iraq Cooperation Council emphasized that while not losing sight of the need to (re)-commit to the general reform path in Iraq and to address the root causes of fragility in a holistic manner, concrete steps on returns were necessary ahead of the June 2023 JHA Council.

While the readmission of own nationals is included as a legally binding obligation in the EU-Iraq Partnership and Cooperation Agreement (art. 105) in force since 1 August 2018, cooperation on non-voluntary returns remains unsatisfactory.

Iraq is one of the countries for which restrictive measures were proposed by the Commission, in July 2021, following the first report under Art. 25a of the Visa Code. The Council, however, decided not to proceed with the proposal at the time. Discussions are ongoing with Iraq on returns, including non-voluntary, through regular meetings with the Iraqi authorities at the political and technical level on concrete steps to improve readmission cooperation, as well as a coordinated joint demarche conducted in Baghdad on 6 May 2023.

This intense engagement culminated in a meeting called by foreign minister Hussein on 23 May 2023, during which he announced a new policy on return and readmission based on the acceptance of all types of returns, and a firm commitment to cooperate and deliver tangible results. A promising shift in approach of the Iraqi government which, however, needs to be put into practice by concrete and consistent results.

E. EASTERN PARTNERSHIP COUNTRIES

ARMENIA

EU relations with Armenia are currently governed by the Comprehensive and Enhanced Partnership Agreement (CEPA) which was signed in November 2017 and entered into force on 1 March 2021 (substantial parts of it had been provisionally applied already since 1 June 2018). This is expanded with a new Partnership Agenda which is currently being negotiated and which will be underpinned by a EUR 270 million Resilience and Growth Plan for Armenia.

The EU-Armenia Mobility Partnership was signed on 27 October 2011. The first EU-Armenia Mobility Partnership High Level Meeting took place in January 2018. The Visa Facilitation Agreement was signed on 17 December 2012 and the Readmission Agreement on 19 April 2013. Both agreements entered into force on 1 January 2014. Both agreements are implemented in a satisfactory manner, the only issue being the high number of unfounded asylum applications. The Commission has recommended to launch a visa liberalisation dialogue with Armenia. The launch might be approved by the FAC on 22 July 2024 [tbc]. Strengthening border management is another strand of EU's cooperation with Armenia; there is a working arrangement between Frontex and Armenia in place since 2012 and strengthened cooperation is currently being considered. The Administrative Arrangement establishing cooperation between the European Commission and the Migration Service of Armenia in the European Migration Network was signed in October 2022.

A Working Arrangement with Europol was signed in 2021 and with CEPOL in 2017; an international agreement between Armenia and the EU on cooperation with Eurojust should be soon signed. Armenia is a beneficiary of the regional capacity-building project TOPCOP, managed by CEPOL and supported by Europol.

In the framework of the EU's support to the rule of law and security sector governance reforms, the EU has supported the establishment of the new Ministry of Interior (MoI) in January 2023. The ongoing support package totals EUR 10 million, including a EUR 3 million component for migration and EUR 4.5 million for police reforms. On migration governance, there are two ongoing projects (EUR 3 million), supporting capacity building of the MoI for effective migration management, and the reorganisation of the Migration and Citizenship Services. In May 2024, the Armenian Government requested Russian FSB Border Guards to withdraw from the 'Zvartnots' airport and from the internationally recognised border with Azerbaijan, while they continue to be deployed on Armenia's borders with Türkiye and Iran.

AZERBAIJAN

EU relations with Azerbaijan are governed by the EU-Azerbaijan Partnership and Cooperation Agreement (PCA), which entered into force in 1999. Negotiations on a framework agreement to replace the PCA started in February 2017 but are currently on hold.

The EU-Azerbaijan Mobility Partnership was signed on 5 December 2013 and the first High-Level Meeting was organised in February 2017. The Visa Facilitation and Readmission Agreements entered into force on 1 September 2014. The Visa Facilitation Agreement and the Readmission Agreement are implemented in a satisfactory manner;. Strengthening border management is another strand of EU's cooperation with Azerbaijan; there is a working arrangement between Frontex and Azerbaijan in place since 2013.

Azerbaijan is a beneficiary of the regional capacity-building project TOPCOP, managed by CEPOL and supported by Europol.

BELARUS

Belarus is the only country in the Eastern Partnership region that does not have a framework document with the EU. The EU-Belarus Partnership and Cooperation Agreement was signed in 1995, but ratification was frozen in 1997. Negotiations on the EU-Belarus Partnership Priorities (a political document of non-binding nature) started in 2016, however were put on hold in 2020. Following fraudulent elections in 2020 the EU scaled down bilateral relations with Belarus, suspended cooperation with the Belarusian authorities and channelled its assistance in support to the people of Belarus, including Belarusian democratic forces and civil society (see Conclusions of 12 October 2020 and 19 February 2024). Restrictive measures and sectoral sanctions have also been adopted.

In 2021, Lithuania, Poland and Latvia experienced an unprecedented increase in irregular border crossings from Belarus, as a result of the Belarusian regime's attempts to incite or acquiesce in irregular border crossings of non-EU nationals into the EU for political purposes. The EU and its Member States strongly condemned this instrumentalisation of migrants and refugees by the Belarusian regime, including in the 2024 Council conclusions. In 2022, the situation has de-escalated at the external EU borders with Belarus with a significantly lower number of arrivals and prevented crossings. Despite a year-on-year increase recorded in 2023, the level of arrivals and prevented crossings remained well below the peak of the crisis in 2021. The situation at the EU-BY border has become more difficult in 2024, with an increase in number of arrivals at the border in 2024, compared to the previous year. The situation however remains complex and unpredictable, and the Commission keeps monitoring the developments.

On 13 October 2016, Belarus and the EU signed a Joint Declaration on a Mobility Partnership. The kick off meeting took place on 10 November 2017. On 1 July 2020, the EU-Belarus Visa Facilitation and Readmission Agreements entered into force. On 28 June 2021, Belarusian authorities announced its decision to suspend the Readmission Agreement (formally notified on 2 December 2021).

On 9 November 2021, the Council adopted the Commission proposal on the partial suspension of the EU-Belarus Visa Facilitation Agreement. The suspension concerns government officials of Belarus (members of Belarus official delegations; members of Belarus national and regional Governments and Parliaments, Belarus Constitutional Court and Belarus Supreme Court). In line with the latest guidelines, DG HOME has suspended any ongoing or planned bilateral engagement with representatives of Belarus, including at technical/expert level.

GEORGIA

The EU – Georgia Association Agreement, including a Deep and Comprehensive Trade Agreement, (succeeding the PCA of 1999), was signed on 26 June 2014 in Brussels and entered fully into force on 1 July 2016.

The Mobility Partnership between the European Union and Georgia was signed in November 2009. The Readmission and Visa Facilitation Agreements with Georgia entered into force on 1st March 2011. Georgian citizens were granted visa-free travel to the Schengen area on 28 March 2017.

A Working Arrangement between Georgia and CEPOL, replacing the previous Cooperation Agreement, was signed remotely on 22 June 2022. Georgia is a beneficiary of the regional capacity-building project TOPCOP, managed by CEPOL and supported by Europol.

Cooperation between Georgia and EMCDDA moved to a new stage in September 2022, when the new Working Arrangement and 2022-2024 work programme came into force. Georgia is also a beneficiary of the first bilateral technical project between EMCDDA and Georgia, the EMCDDA4GE, which is focused primarily on knowledge transfer and capacity building in the areas of drug monitoring, reporting, prevention and treatment.

An operational Agreement enabling the exchange of personal data with Europol has been in force since 2017.

A revised working arrangement between Frontex and Georgia was signed on 11 February 2021. In 2021, Georgia became an observer in the European Migration Network.

*Georgia applied for EU membership on 3 March 2022. The European Council recognised the **European perspective** for Georgia in June 2022 and Georgia was granted **candidate status** in December 2023, on the understanding that the relevant nine steps set out in the Commission recommendation of 8 November 2023 are taken. As a result of the democratic backsliding marked by several legislative and political decisions of the governing authorities, including the adoption of the Law on transparency of foreign influence, the European Council concluded on 27 June that the accession process has come de facto to a halt.*

The sixth report under the visa suspension mechanism adopted in October 2023 concluded that overall Georgia continues to fulfil the visa liberalisation benchmarks and has taken action to address the Commission's previous recommendations. However, further efforts are needed, in particular regarding the alignment of Georgia's visa policy with the EU's list of visa-required third countries, the issue of unfounded asylum applications and irregular stays in Member States, on asset recovery and anti-corruption.

REPUBLIC OF MOLDOVA

The EU-Republic of Moldova Association Agreement, including a Deep and Comprehensive Free Trade Area, (succeeding the PCA of 1994), was signed on 27 June 2014 and fully entered into force on 1 July 2016.

The EU-Moldova Visa Facilitation Agreement and Readmission Agreement entered into force in January 2008. An amended Visa Facilitation Agreement entered into force in July 2013. A Mobility Partnership was signed in June 2008. Moldovan citizens were granted visa-free travel to the Schengen area on 28 April 2014. Moldovan citizens continued to benefit from visa-free travel to the EU and the Schengen Associated Countries. From 28 April 2014 until 31 December 2020, some 2 366 647 Moldovan citizens made almost 9 million trips to the Schengen area under the visa-free regime. The fifth report under the Visa Suspension Mechanism adopted in December 2022 confirmed that Moldova continues to fulfil the visa liberalisation benchmarks. At the same time, it also identified that further efforts were needed to address the issues of unfounded asylum applications, alignment of Moldova's visa policy with the EU lists of visa-required third countries as well as in the areas of financial fraud, anti-money laundering, the prevention and fight against corruption and organised crime.

Moldova concluded agreements or arrangements with the European Border and Coast Guard Agency (Frontex) since 2005. A Status agreement was signed on 17 March 2022. An operational and strategic cooperation agreement is in force with Europol (2015), and so is a working arrangement with CEPOL (2012). Moldova is a beneficiary of the regional capacity-building project TOPCOP, managed by CEPOL and supported by Europol, as well as of the project EU4Security, also managed by CEPOL and funded by the EU Delegation. The European Union Border Assistance Mission to Moldova and Ukraine (EUBAM) redirected and scaled up its activities to assist in managing the influx of refugees (with additional EUR 15 million) and support on Solidarity Lanes. Amendment of EUBAM's mandate was signed on 6 June 2022, allowing executive powers for border checks and customs controls, if requested.

In 2021, Moldova became an observer in the European Migration Network.

Moldova was awarded EU candidate status on 23 June 2022. On 14 December 2023, the European Council decided to open accession negotiations with the country. The first intergovernmental conference marking the formal launch of the accession negotiations was held on 25 June 2024.

Russia's war of aggression against Ukraine is having severe spill-over effects on Moldova. Since 24 February 2022, over 8 958 700 Ukrainian nationals have entered Moldova (via the MD-UA border sector), of which roughly 1 029 300 have remained. Since March 2023, 36 860 63 141 displaced persons from Ukraine have registered for Temporary Protection in the Republic of Moldova, 28 332 51 314 are documented under the Temporary Protection regime in Moldova. The EU has been mobilising several strands of assistance since the outbreak of the war (humanitarian, border and migration management, security, energy, trade). In parallel, the programmed assistance is being re-purposed to strengthen Moldova's resilience. Transfers of vulnerable people are also taking place from Moldova to the EU, under the Solidarity Platform, coordinated by the Commission. Since March 2022 Member States, Norway, Liechtenstein, Switzerland, and Iceland (EU+) made pledges to welcome 17 870 people transiting Moldova. Out of the pledges made so far, a total of 2 869 persons have been transferred (including 249 by Lithuania on a bilateral basis) to the EU+ from Moldova, mostly via air (charters and commercial flights), within the agreed workflow in cooperation with UNHCR, IOM and the support of EUAA. In order to support transfers, DG NEAR is running a programme implemented by IOM Moldova entitled "Supporting Protection, Transit, Voluntary and Informed Return and Reintegration of Eastern Partnership Citizens and Third Country Nationals affected by the conflict in Ukraine" with a budget of €15 million for a duration of 36 months (having started retroactively on 24 February 2022).

UKRAINE

The Partnership and Co-operation Agreement (PCA) entered into force in 1998. Negotiations on an EU-Ukraine Association Agreement started in September 2008 and initialled in 2012. Ukraine and the EU parliament simultaneously ratified the economic and political parts of the Association Agreement on 16 September 2014.

The Readmission and Visa Facilitation agreements were concluded in 2008. An amended version of the Visa Facilitation agreement with Ukraine entered into force in July 2013. As of the 11 June 2017, Ukrainian citizens, can travel visa-free to the Schengen area. The fourth report under the Visa Suspension Mechanism adopted in August 2021 confirmed that Ukraine has taken actions identified in the Third Report and the visa liberalisation benchmarks continue to be fulfilled.

An operational Agreement enabling the exchange of personal data is in force with Europol and a Working Arrangement was concluded with CEPOL. Ukraine is a beneficiary of the regional capacity-building project TOPCOP, managed by CEPOL and supported by Europol.

The fifth visa suspension mechanism report covered the period up until the end of 2021, and mainly reflected the situation before the start of Russia's unprovoked and unjustified military aggression against Ukraine on 24 February 2022. Under the exceptional circumstances, the visa-free regime between the EU and Ukraine has allowed to facilitate travel to and from Ukraine, in particular for those Ukrainian nationals who decided not to take up residence in the EU or do not fall under the scope of the temporary protection directive. The sixth report, published in October 2023, concluded that Ukraine continues to meet the visa liberalisation benchmarks.

The Administrative Arrangement establishing co-operation between the European Commission and the State Migration Service of Ukraine in the European Migration Network was signed on 2 August 2022.

The Russian invasion of Ukraine has quickly led to the fastest-growing movement of people in Europe since World War II. The EU remains committed to supporting people fleeing Ukraine, as well as EU Member States and Eastern Partner countries directly affected.

On 4 March 2022, the EU activated the Temporary Protection Directive to offer immediate support and protection to the people fleeing the war in Ukraine. On 2 March, the Commission adopted operational guidelines for external border management to facilitate border crossings at the EU-Ukraine borders. temporary protection has been extended until March 2024 temporary. A Solidarity Platform has also been set up and a 10-point Action Plan presented by Commissioner Johansson in order to support various strands of action.

'The mandate of the European Union Border Assistance Mission to Moldova and Ukraine (EUBAM) has been expanded to provide executive powers to the mission to support the Moldovan border police with border control and strengthen its capacity and human resources, and a new regional action of EUR 15 million, implemented in partnership with IOM, has been adopted to ensure the protection and facilitate the transit, voluntary return and relocation of Ukrainians and third country nationals from Moldova to the EU and to countries of origin.

The temporary protection is extended until March 2026.

Ukraine was granted candidate status on 23 June 2023.

Accession negotiations formally started on 25 June 2024. First bilateral screening meeting held on 8-9 July on "acquis" chapter 5 (Public Procurement). Chapter 23 (Judiciary & Fundamental Rights) scheduled for September 2024, chapter 24 (Justice, Freedom & Security) in October, with full screening of all 6 clusters and 35 chapters expected by Autumn 2025.

F. RUSSIA

The EU-Russia Partnership and Cooperation Agreement (PCA) came into force in 1997. Ministerial meetings for Freedom, Security and Justice area were organised regularly until the illegal annexation of the Crimean peninsula / Ukraine (2014) by Russia. The Visa Facilitation and Readmission Agreements entered into force on 1 June 2007. On 11 April 2011, the Council adopted a mandate for the renegotiation of the Visa Facilitation Agreement. However, further cooperation with Russia in the Home Affairs area was affected by the illegal annexation of the Crimean peninsula and Russian military destabilisation of eastern Ukraine (2014), which led to the introduction of sanctions against Russia. Meetings at ministerial and senior officials levels and all negotiations on new home affairs agreements, namely on visa liberalisation, upgraded Visa Facilitation Agreement (VFA), and Eurojust (agreement on operational cooperation), have been suspended. The Strategic Agreement signed with Europol in 2003 has also been suspended. A Working Arrangement with CEPOL (2013) is not being implemented either. Following the Russian full-scale military invasion of Ukraine (24 February 2022), any ongoing or planned bilateral engagement with representatives of Russia has been suspended, including at technical/expert level.

Following the Russian full-scale military aggression against Ukraine, the Commission immediately proposed a partial suspension of the Visa Facilitation Agreement. On 25 February 2022, the Council adopted the Commission proposal, targeting Russian government officials, Russian diplomats and business persons. On 4 April 2022, Russia also partially suspended the EU-Russia Visa Facilitation Agreement, targeting EU diplomats, MS or EU officials, and journalists. On 9 September 2022, the Council adopted a decision to suspend the Visa Facilitation with Russia in full. In addition, on 9 September 2022, the Commission presented the guidelines to support Member States' consulates in handling short-stay visa applications lodged by Russian citizens. The guidelines follow the political agreement reached by Foreign Affairs Ministers at their informal meeting of 31 August on a common and coordinated way forward when it comes to visa issuance for Russian citizens and ensure a consistent approach across consulates. On 30 September 2022, following the announcement of a partial mobilisation in Russia and sham referenda in the occupied regions of Ukraine, the Commission adopted the updated guidelines to Member States on visa procedures as well as on border controls for Russian citizens at the EU's external borders. The guidelines call for reinforced security scrutiny when issuing visas to Russians and heightened border controls, while fully respecting EU asylum law. In December 2022, the EP and Council adopted the Decision on the non-acceptance of Russian travel documents issued in the occupied regions of Ukraine and in the breakaway territories of Georgia. The Decision brings legal certainty and ensures a coordinated and uniform approach across the Schengen area when it comes to these passports and the crossing of borders. Starting from November 2023, there was a significant increase in third country citizens without Schengen visa or residence permit who were allowed by the RU Border Guard Service to cross the Finnish-Russian border. Following a decision by the Finnish government, the border crossing points with Russia remain closed for an indefinite period. In the course of 2023, in particular in the summer, there was an increase of illegal migrants arriving from Russia at the Belarusian-Polish border with Russian tourist and work visas, implying an active involvement of Russia in steering migration crisis.

G. UNITED STATES OF AMERICA

*Relations between the EU and the US were formalised in 1990 in the Transatlantic Declaration, and further developed in the New Transatlantic Agenda which outlined a new framework for cooperation including a number of areas for joint action. An EU-US Joint Statement endorsed by the EU-US JHA Ministerial Troika in October 2009 (the so-called "Washington Statement") sets out common values and foundations of EU-US cooperation in the JHA area until 2014 and includes a commitment to enhance both political and operational cooperation in various JHA issues. In 2015, the framework of the EU-US cooperation for 2014-2020 was further developed in the "**Renewed EU-U.S. Statement on Enhancing transatlantic cooperation in the area of Justice, Freedom and Security**".*

Europol cooperates very closely with the US and an operational Agreement enabling the exchange of personal data is in force with the Agency.

Further to this commitment cooperation has been developed on migration and asylum issues in the context of the EU-US Cooperation Platform on Migration and Refugee issues, launched in 2010. Activities included areas such as unaccompanied minors, biometrics, refugee resettlement, trafficking in human beings and development of capacity building for migration management in third countries and contribution of the Diaspora to the development of countries of origin of migration. The dialogue was not continued under the Trump administration and restarted again in November 2021 with a meeting dedicated to Afghanistan. Issues related to border management and visas are also discussed in the regular EU-US Justice and Home Affairs Senior Officials and Ministerial meetings.

B. THE EASTERN PARTNERSHIP PLATFORMS AND PANEL ON MIGRATION, MOBILITY AND INTEGRATED BORDER MANAGEMENT (IBM)

The Eastern Partnership is the framework for cooperation between the EU and Armenia, Azerbaijan, Belarus, Georgia, Moldova and Ukraine. The latest Joint Declaration was adopted at the Eastern Partnership Brussels Summit of December 2021. The leaders committed to enhancing their cooperation on the basis of the EaP policy beyond 2020. The five long-term objectives of the EaP policy beyond 2020 emphasise recovery, resilience and reform as key building blocks of the future agenda. The long-term objectives are: (i) developing resilient, sustainable and integrated economies, (ii) ensuring accountable institutions, the rule of law and security, (iii) developing environmental and climate resilience, (iv) delivering a resilient digital transformation, (v) creating resilient, gender-equal, fair and inclusive societies.

C. THE BUDAPEST PROCESS

The Budapest Process was initiated in 1991 as a consultative forum, currently containing more than 50 governments and 10 international organisations, aiming at developing comprehensive and sustainable systems for orderly migration. Within the Budapest Process, a Silk Routes Partnership for Migration was established at the Ministerial Conference held in Istanbul on 19 April 2013. The Istanbul Declaration sets out the main objectives and activities of the countries along this migratory route. This Dialogue is instrumental to reinforce cooperation at regional level with priority Silk Route countries, with which the EU engages on migration through various bilateral frameworks.

E. THE RABAT PROCESS

The Rabat process was launched at the first Euro-African Ministerial Conference on Migration and Development that took place in July 2006 in Rabat. The process aims to enhance dialogue and cooperation between countries of origin, transit and destination along the West African migration route. The fourth ministerial conference was held in Rome in November 2014 where Ministerial Declaration and Action Plan for 2015-17 were adopted. The fifth ministerial conference held in Marrakesh, May 2018, adopted the Marrakesh Programme of Action which aligned the work of the Rabat process with the five themes of the Joint Valletta Action Plan, This dialogue contributes to the implementation of the Valetta Action Plan, adopted at the EU-Africa Summit on Migration on 11-12 November 2015.

F. THE KHARTOUM PROCESS

The Khartoum Process (the EU Horn of Africa Migration Route Initiative) is a framework for dialogue and cooperation with countries of origin, transit and destination along the migratory route from the Horn of Africa to Europe. It primarily focuses on smuggling of migrants and trafficking in human beings but includes also other areas of migration management including the root causes of irregular migration, legal migration and mobility, asylum and international protection, fight against irregular migration and smuggling of people, and return and readmission. The Khartoum Process contributes to the implementation of the Joint Valletta Action Plan adopted at the EU-Africa Summit on Migration on 11-12 November 2015.

G. THE ACP-EU MIGRATION DIALOGUE

The ACP-EU Migration Dialogue was launched in June 2010 through a Joint Declaration of the ACP-EU Joint Council. The dialogue is based on Article 13 of the Cotonou Agreement. In May 2011, it was decided to further deepen the dialogue, focusing in particular on 4 thematic areas (Visa, remittances, returns and readmission, THB and smuggling of migrants), with the specific aim to strengthen the operational aspects of ACP-EU cooperation on these topics. In 2020, the African, Caribbean and Pacific Group of States became the Organisation of African, Caribbean and Pacific States (OACP).

A series of expert meetings took place on a yearly basis. A joint report including recommendations on remittances, visas and readmission was adopted in June 2012 at the ACP-EU Joint Council of Vanuatu. A Joint Visa subgroup meeting, technical workshop on return and readmission and experts' seminar on trafficking in human beings and smuggling of migrants took place in 2014. The last technical dialogue took place in June 2018.

The Dialogue (and in particular the organisation of the thematic meetings) was supported by the EU- ACP Migration Action, a EUR 10M programme which implemented some of the recommendations. The programme finished in August 2019. A final evaluation was carried out and its outcome was presented to EUMS at the OACP WP of 3 June 2020. The Programme covered three components: 1) Demand- driven provision of technical assistance (requested by OACP countries or by regional institutions); 2) Direct support to NSAs projects improving the conditions of migrants and their families; 3) Collection of good practices and dissemination of results.

Both the EU and the OACP sides expressed concerns about the effectiveness of this Dialogue, particularly on the interaction between the political and the technical level, and saw the negotiations of the Post Cotonou Agreement as an opportunity to revisit the EU-OACP migration dialogue and its implementation. The new Agreement reaffirms the enhanced cooperation on migration and mobility, paying particular attention to circular migration, recognising the positive impacts of migration and mobility on sustainable development and addressing the negative effects of irregular migration on countries of origin, transit and destination. It also contains the legally binding annex on return and readmission process.

Once the new Partnership Agreement, signed by the EU and its Member States with the Members of the African, Caribbean and Pacific States (OACPS) in Samoa on 15 November 2023 enters into force, the OACP-EU Development-Migration Dialogue will be replaced by the Partnership Dialogue, the modalities of which still have to be defined. The dialogue on migration and mobility will become part of a wider dialogue, encompassing all policy areas covered by the agreement.

At the Summit it was decided that the existing mechanisms of the Rabat Process, the Khartoum Process and of the Joint EU-Africa Strategy would be used to monitor implementation of the Action plan.

I. THE EU-CELAC MIGRATION DIALOGUE

The EU and Latin America and the Caribbean countries (CELAC) Structured and Comprehensive Dialogue on Migration was launched in June 2009 following the mandate of the EU- LAC Lima Summit. The EU-CELAC Action Plan, adopted at the 2010 Madrid Summit, called for further developing this Dialogue. This commitment was renewed during the last EU-CELAC Summit held in Brussels in June 2015.

Part 3 - The global processes

A. GLOBAL FORUM FOR MIGRATION AND DEVELOPMENT

The GFMD is an initiative of the UN Member States to address the migration and development nexus in practical and action-oriented ways. It is an informal, non-binding, voluntary and government-led process.

The process emerged after the UN High-level Dialogue on International Migration and Development on 14-15 September 2006. The second High-level Dialogue on 3-4 October 2013 confirmed the GFMD as a valuable forum for holding frank and open discussions, which has helped to build trust among participating stakeholders.

The 8th GFMD Summit came immediately after the adoption of the 2030 Agenda for Sustainable Development, which includes migration as a recognised development enabler. During Turkey's Chairmanship, an important feature was the insertion of forced displacement and refugees on the agenda, not the least due to the Syrian refugee crisis.

*In order to position the Forum's discussions at the heart of the 21st century priorities, the GFMD 2022-2023 Chairmanship Senegal-France has chosen "**the impact of climate change on human mobility**" as the main topic.*

B. UNITED NATIONS

The 2030 Agenda for Sustainable Development adopted by the United Nations General Assembly on 25 September 2015 recognizes that migration contributes to circular growth and development. It calls on UN Member States to increase international cooperation by facilitating orderly, safe, regular and responsible migration and mobility of people. In this respect, the EU counts on a long-standing strategic partnership with the UN. In December 2018, the Global Compact for Safe, Orderly and Regular Migration (GCM) and the Global Compact on Refugees (GCR) were adopted by the UN General Assembly. This concluded the intense two-year process launched with the adoption of the New York Declaration for Refugees and Migrants in September 2016. Follow-up and review under the Global Compact on Refugees will be conducted through the Global Refugee Forum (held every four years unless otherwise decided); high-level officials' meetings (held every two years between Forums); as well as annual re- porting to the United Nations General Assembly by the United Nations High Commissioner for Refugees .The first Global Refugee Forum took place on 16-18 December 2019. The first High-level Officials Meeting took place on 14-15 December 2021 to take stock of progress and look ahead to the next Global Refugee Forum. UN Member States will review implementation of the GCM through the International Migration Review Forum, to take place every four years beginning in May 2022.
